May Increase U. S. Army by 50,000 Men

Dern Thinks That Nation's Forces Are "Below the Danger Line"

Washington, Aug. 6.—A campaign to increase the size of the regular army to 165 thousand men...

Dern's inspection of Panama canal defense and army posts throughout the west is said at the department to have confirmed the general staff's contention...

The war department consequently has prepared concrete plans to increase the present active force 118 thousand men and 12 thousand officers...

Thompson plans for the enlarged army to become a semi-relief measure. An increase of the army by 50 thousand now will, he argues, take that many young men off relief rolls...

To accomplish a saving in appropriations—despite the additional 35 million dollars required—Thompson proposed that the army absorb some of the men now enrolled in CCC camps.

The war department's position, however, is that completely aside from any relief or economy objectives, the army needs to be increased for reasons of national defense.

The army is organized, according to General MacArthur, to protect outlying possessions, train civilian components in time of emergency, and form a permanent force to repel any invaders.

At the present time, according to MacArthur, the army's strength is not sufficient to carry out those three tasks simultaneously.
