

State Relief Plan is Mapped with Cochran

Legislative Groups Discuss Tentative Moves; Firemen Pension Bill Goes to the House

From Saturday's Daily
Drafting of Nebraska's relief plan began yesterday at Lincoln in a conference between Governor R. L. Cochran and committees from the two houses of the legislature.

Cochran said methods of allotting funds to the counties and state versus county administration of the proposed 2 million dollar state relief appropriation were discussed only tentatively. The legislators were asked to return today to resume the discussion.

Routine Day in Legislature

The legislature closed the week on Friday with one of the most routine days of the session. The house spent most of the day debating a bill by Representative F. A. Reuter (D), of Syracuse, to permit non-attorneys to file papers in estate cases in county courts, but despaired of action after two tie votes.

The senate passed and sent to the house two Omaha firemen's pension bills and a minor measure on license fees for optometrists.

Two joint sessions enlivened the day. Arthur F. Mullen, of Omaha, former democratic national committeeman from Nebraska, spoke against ratification of the federal child labor amendment at the first joint meeting. Unanimous confirmation of Governor Cochran's appointment of J. Frank Haskin, of Benkelman, to the state game, parks and forestation commission was effected at the other meeting.

No report was made by a committee which has been investigating the recess appointment of W. J. Tiley of North Platte to the commission almost a year ago by former Governor Bryan.

Uniform Delinquent Date

Repeal of the month extra time given Douglas and Lancaster county auto owners for purchase of licenses Friday bore the endorsement of both house and senate committees. A bill to make February 1 the uniform delinquent date for motor vehicle licenses was reported favorably by the house revenue and taxation committee. A senate group recommended a similar bill a few days ago.

BURKE SPEAKS FOR VOTAVA

Washington. — Senator Burke, democrat, Nebraska, announced he has sent in his recommendation for the appointment of Joseph T. Votava of Omaha as U. S. district attorney in Nebraska.

Burke said in making the recommendation to the attorney general, however, he had called attention to the desire of Senator Norris to have C. E. Sandall, present district attorney, left in office until the perjury case against Victor Seymour of Lincoln, Neb., is disposed of. A hearing on Seymour's appeal has been set for the circuit court for March 12. Appointment of Votava by March 15 was suggested by Burke.
