Starting Work on the Paving
A crew of workmen was placed on the section of the O street road that is to be paved last Monday. They are removing the gravel from the highway and spreading it on the road that will be used as a detour route during the time the grading and paving work is in progress. The plan is to route the detour road four miles east of Elmwood, thence north to the Elmwood-Weeping Water road, which is already graded. The east and west stretch of this route is ready for the gravel, but considerable grading will be required to place the north and south stretch in condition for graveling and until that is done the temporary detour route will run east to the Cascade school, two miles south of Weeping Water, and thence south to the Weeping Water corner on the O street road. It is expected the grading will be completed in a short time, thus providing an all weather detour.

The new paving will extend east from the Elmwood corner a distance of four miles, and it is expected a further contract will be made this spring providing for the paving of some of the additional gap, beginning at the east end of the present paving—perhaps to include all of it, thus providing a paved road straight through from the Union corner to Lincoln.
