ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of forming a banking corporation as provided by the laws of the State of Nebraska, and do adopt the following Articles of Incorporation:

Article I—The name of this corporation shall be UNION STATE BANK.

Article II—The principal place of business of this corporation shall be at Greenwood, County of Cass, State of Nebraska.

Article III—The object for which this corporation is formed is to carry on a commercial banking business as provided by the Laws of Nebraska.

Article IV—The authorized capital stock of this corporation shall be \$25,000.00, of which at least \$10,000.00 shall have been paid in at the time of commencement of business, which shall be issued in shares of the par value of One Hundred (100) Dollars each. No transfer of the stock of this corporation shall be operative until entered on the books of the corporation.

Article V—The indebtedness of this corporation shall at no time exceed the amount of its paid-in capital and surplus except for deposits.

Article VI—This corporation shall begin business on the 1st day of July, 1936, or as soon thereafter as authorized by the Department of Banking of the State of Nebraska, and shall terminate on the 1st day of July, 1966.

Article VII—The affairs of this corporation shall be under the control and management of a board of directors consisting of not less than three nor more than five shareholders, whose term of office shall be for a period of one year, or until their successors are elected and qualified, not less than a majority of whom shall be residents of the county in which the bank is located or counties immediately adjacent thereto. It shall be the duty of the board of directors to elect from their number a president and secretary, and select a vice president and cashier, and they may also select an assistant cashier and such other clerks and assistants as the business of the corporation may require. The term of office of the officers of this corporation shall be one year, or until their successors are elected and qualified. The board of directors may adopt such by-laws for the regulation and management of the affairs and business of the corporation as it may deem proper.

Article VIII—The regular annual meeting of the stockholders of this corporation shall be held on the first Tuesday of January each year, at which meeting the board of directors above provided for shall be elected. A majority of the shares of stock of the corporation at any regular or special meeting shall constitute a quorum for the transaction of business.

Article IX—Until the regular meeting of the stockholders of the corporation, the following named persons shall constitute the board of directors: L. J. DUNN, B. M. HANSON, E. A. LANDON.

Article X—Each stockholder shall at any regular or special meeting be entitled to one vote, either in person or by proxy, for each share of stock held.

Article XI—These articles of incorporation may be amended by a two-thirds vote of all the stock at any regular or special meeting called for the purpose.
