### FRANCIS SCHLATTER DE-PARTS FROM DENVER.

Leaves a Br'ef Note Behind Him. With Nothing to Indicate His Whereabouts-Touch Sorely Disappointed.

DENVER, Colo., Nov. 15 .- Thousands. of people, poor and afflicted, waited patiently under the lowering skies and chill wind this morning for the appear- to be safe. ance of Francis Schlatter, the healer. When he failed to appear a bitter murmur arose, and the disappointment was keen. Then rumors were passed from one mouth to the other and the whole city was lost in conjecture. Some had it that he was seen near Greeley, others claimed he was walking hatless and shivering over the fields near Golden and that he took the night train to Chicago. Conflicting reports were rife.

All that was positively known was that he had departed from the Fox home in the night, taking all his gifts of warm clothing and leaving behind this brief note:

Mr. Fox: My mission is finished. Father takes me away. Good-bye. FRANCIS SCHLATTER.

The crowd was at first inclined to make trouble, but they withdrew after demolishing the fence for souvenirs. Many touched the boards on which Schlatter had stood and thus carried away his mystic influence.

WANTED AS A WITNESS. Schlatter was subpoenned early in

October to appear before United States Comissioner Capron today to testify in the case of the three manufacturers of fraudulent blessed handkerchiefs. When Schlatter failed to appear this morning and it was definitely ascertained that he had skipped town, the case was postponed until Saturday morning at 10 o'clock. Commissioner Capron said this morning:

> News of the destruction of the Gosper county court house by fire reached State Auditor Moore vesterday in a telegram from C. A. McCloud, one of the state examiners whose duty it is to inspect the books of each county treasurer at least once in two years Mr. McCloud was at Elwood for the purpose of making the usual biennial examination. His message to the auditor said the county records were supposed to be all right. Reports on file in the state auditor's office show that County Treasurer W. E. Aldrich settled in full with the state last January His office was examined by Mr. Mc-Cloud November 23, 1893, and the report showed that there was a discrepancy of \$427.26 between the books and cash, but in a footnote the examiner explains that this was accounted for by the treasurer anticipating his commission on the collection of state taxes. The examiner found fault, however, with some investments made by the treasurer, but he added that they were authorized by the county board.

## A BEET SUGAR BOYCOTT

#### The Trust Makes War on the Nebraska Product.

CMAHA, Neb., Nov. 15 .- The growth of the beet sugar industry in this state has attracted the attention of the sugar trust, which has already taken steps to prevent the sale of Nebraska sugar. Jobbers and dealers have been notified that if they sell the refined product of Nebraska factories the trust will decline to sell them the cheaper grades, which are not manufactured by the Oxnards. The result of this is that over \$100,000 worth of Nebraska made sugar is stored in warehouses in Omaha. The matter has been laid before the Manufacturers' and Consumers' Association and efforts are being made to get Western jobbers to agree to handle the Nebraska product regardless of consequences. ## THE TURKISH PROBLEM. Scrofula from Infancy Six European Governments Sychange

Views-Considering a Policy.

LONDON, Nov. 15,-A dispatch from Vienna says that on the initiative of Count Goluchowski, the Austrian minister of foreign affairs, a formal exchange of views of the cabinets of the six powers has commenced, with a view to arriving at a collective decision as to the best way of dealing with the Armenian problem.

The Vienna correspondent of the Standard says that the foreign ambassadors possess ample evidence that the palace elique at Constantinople issued orders that the troops and police should only fire upon Armenians, no matter who the aggressors were. Observers of political events at Constantinople have noted that all the imperial princes are now living at Yildizkiosk.

The Daily News prints a dispatch from Odessa to the effect that it has been officially announced there that the commander-in-chief of the Caucasus army and the admiral of the Black sea have definite instructions from St. Petersburg advising them what course to pursue in event of the disruption of the Ottoman empire.

A dispatch from Constantinople says that a witness of the Erzeroum massacre confirms the statements regarding the prearranged nature of the outsounded before the soldiers commenced their murderous work throughout the city. At first the Turkish troops refrained from injuring women and children, but these bounds were soon passed and October 13 the disorders lasted fully six hours. Four hundred refugees were sheltered at the governor's house and fully 300 Armenians concealed themselves in the homes of the Europeans. Two hundred and four horribly mutilated corpses were collected in the Armenian quarter and the plundering went on at a wholesale rate, according to the account of this witness, who adds: "I heard of acts of the basest treachery. The next day passed quietly, but on the following day the massacre was resumed. Thirty-six bodies were collected, and nearly all had builet, sword and bayonet wounds. 1 saw the bodies of several women who died in defense of their Some of the bodies had been honor. skinned, other bodies had been partly burned through the use of petroleam. 

A Lively Street Duel Between Detectives and Crooks at Chicago.

CHICAGO, III., New. 15 .- A man who was supposed to be Clarence White, one of the gang of porch-climbers who last spring robbed the residence of Norman E. Ream on Lake Shore drive of thousands of dollars worth of diamonds, was killed tonight by a detective belonging to the Berry agency, At midnight the identity of the dead man was uncertain. The Borry men have been trying to find White ever since the Lake Shore robbery occurred, and early this evening five of them were standing on the corner of Winthrop Place and Polk street. There are many contradicting stories as to what happened, but that two mes drove by and that there was much shooting is a certainty. As near as can be learned two men came by in a buggy.

When they were opposite the Berry detectives they opened fire, and some say the occupants of the buggy fired three shots before the detectives could draw their revolvers. As soon as they did, however, ther was a fusillad of shots. The excitement on the street was intense. Pedestrians ran in all directions and sought shelter in convenient doorways. 
