OFT ON A STRIKE. Union Pacific Shopmen Quit

Work.

THE CAUSE OF THE DIFFICILTY.

Blungrooment they Matters Partaining in the Control of the Workman-Man at Denter Will Awall Parther Instructions From Omaks At thiker Points.

Omana, April 18 - Five hondred machinists and helpers at the Union Pacific shops here, and 50 at North Plaite, struck under orders from the Federation of Machinery Constructors, upon the company refusing to sign an agreement to make more binding the plan of a schedule day of nine hours.

The employee claim that the company has acted in bad faith concerning the fulfillment of an agreement entered into to allow the force of men employed to reduce itself when the time was below the standard of nine hours a day. It is claimed that the company, instead of allowing the force of men employed to reduce itself naturally has kept up the full quots of men and in some shops, Omaha included, has increased the force,

Omaha included, has increased the force. The company not only increased the force but reduced the standard of time of nine hours to eight hours for a work-ing day January 15 of this year. The strike naugurated affects about 2,100 men on the system and only interests the workers of iron or those men who are working eight hours, as they allege they were promised on Jan. 15. The towns to be most affected by the strike in addition to Omaha, are Denver, Cheyenne, Salt Lake, Rawlins, Armstrong. Pocatello, Evanston, Lara-mie, La Grande and Shoshone.

Did Not Go Out at Denver.

DENVER, April 18.-The men in the Union Pacific shops in this city did not go out, but it is probable they will follow the example of the men at other points. It seems to be a fight between the unions and the Knights of Labor

the unions and the Knights of Labor here, and the Knights have won in the preliminary skirmishes. Several tele-grams have been sent to Omaha by the union men, who are only waiting the word to go out, but up to a late hour no reply had been received. Should the strike go into effect, there are about 15 trades unions who will walk out of the Denver shops, while about 200 of the men who belong to the Knights of Labor would probably remain at their poets.

The Knights of Labor were notified

The Knights of Labor were notified by their executive board that the strike ordered by the unions was in support of a demand for an agreement with the company covering only machinists, boilermakers and blacksmiths, and which is in direct opposition to the spirit of the agreement entered into by the company with the Knights of Labor, and they would be expected to oppose it. A meeting will be held, which promises to be long and stormy. At a meeting of the Union Pacific shopmen held here it was decided to send a committee to Omaha to see if some arrangements could not be made to

some arrangements could not be made to svoid a strike here. Until this commit-tee is heard from it is probable no strike will occur in this city.

The Situation at Cheyenne toilermakers and machinists employed in the Union Pacific shops at this point In the Onion Pacinc shops at this point have struck. It was expected that the blacksmiths would also go out, but so far they have not done so. The strik-ing men held a meeting at which the situation was discussed. Many of the striking mechanics are dissatisfied with the order received which compels them to quit work, and at the meeting this element gave expression to views anelement gave expression to views an-tagonistic to the course that has been pursued. The blacksmiths and wood-workers refused to become a party to the arbitrary action of the men who have struck. There is no little excitement about town over the strike and people of this city universally regret the hasty action of the men. Quit Wor. at Armstrong.

ZANTE AGAIN VISITED.

Awful Ravages of Earthquakes on the Island.

ATHENS, April 18 .- The island of Zante, one of the principal Ionian islands, was visited by a destructive earthquake, resulting in great loss of life and property. The greater part of the city of Zante was destroyed. The streets are a few hundred, many persons were filled with wrecked houses. The bodies turned away from the doors. of 20 persons, killed by falling walls, have been recovered. It is feared many more are dead in the runs. The number of injured amounts into the hundreds. account of the confusion. A large number of buildings were thrown down, among them St. Dionysius' thrown down, among them St. Dionysins' church and the government offices. The whole island was devastated. Many villages were destroyed and the loss of life is very great. The full extent of the calamity cannot be estimated at present. Since morning two more heavy shocks have shaken the whole island of Zante. The people are fleeing from all the towns to find safety on the plains and hillsides. All are 'terror-stricken. Thousands are without shelter, and few have sufficient food.




