—A brand new son arrived at the home of Hall Elbert on yesterday morning. The mother and son are both reported as doing well.
—There has been but one day of school so far, the school being closed for some reason. It will re-open on next Tuesday, Sept. 17th, and it is not probable that there will be any more interruptions.
—From the way the trains of stock are going down the line on their way to market of late one would be led to believe that the prices of stock must be booming. Trains go by at all hours of the day and night.
—The village board has advertised for bids to operate the steam pump. During the time that it takes to get the matter fixed up S. Barker is doing the necessary work to keep up the water supply. This is much cheaper for the taxpayers.
—The prospects for a heavy immigration to Sioux county between now and spring are very flattering. Letters are coming from people all over the country asking about the chances to secure government land here. It will not be long until vacant land will be scarce in north western Nebraska.
—Judge Kinkaid has sent word to Clerk of the District Court Jameson, adjourning the fall term of the district court for Sioux county from September 11th, to December 11th. This will bring the term at a season of the year when the farmers who will be called to serve as jurors can best spare the time.

Cook was in Harrison on Tuesday and informed us that the Sioux City & Ogden surveyors were busy making their survey through the south part of the county and that he had been engaged to assist them in laying out the route west for some distance into Wyoming. It looks as if Sioux county would get another long line of railroad in the near future.

—Candidates for county offices are canvassing the town and county to get solid with the politicians, and Rosa & Thompson are selling 14 pounds of evaporated apples for \$1.
—A change occurred this week in the firm of Conley, Reidy & Pollard, R. T. Conley retiring. The land and loan business will be continued by Reidy & Pollard and Mr. Conley will devote himself exclusively to his law practice. He will office with Reidy & Pollard for the present, at least.
—Saint James was brought to Harrison Tuesday and a crowd of insanity, composed of Clerk of the District Court Jameson, E. D. Satterlee and Dr. Satterlee, was organized and the patient was examined as to his sanity. The result was that the examination proved that the man was insane and Sheriff Pfost took him to Norfolk on the afternoon train and will leave him at the hospital for the insane. It is to be hoped the treatment he will receive there will restore him to his senses. He is a young man not yet thirty years old, and it is sad that he should become so that is no matter for himself.
—The United States troops have been ordered out for field work, with seven days' rations and not having regular army life. They get after each other and have sham battles. On Wednesday morning the hardest fought battle so far was fought a few miles northeast of this place in Sowbelly Canyon. One person got hurt and was brought here by the hospital ambulance and put on the train for Ft. Robinson. The soldiers report that while there is a good deal of hard work with it, the practice is very interesting. The encampment will probably close shortly after the return of the soldiers in Camp Crook.
—The state fair is in full blast and we see by the reports that a number of counties have exhibits. This is one of the best methods to advertise a locality that can be desired. The state fair of Nebraska is looked upon by manufacturers and stockmen as one of the best places at which to exhibit what they have for sale and the people ought to take advantage of their experience and use it to advertise the locality in which they live. It is to be hoped that the people of Sioux county will keep the matter in mind and begin in time so that next year Sioux county will be in the list of the enterprising counties who have exhibits.
—Con Lindenman has a fine spring on his place but it is located in a ravine with steep banks. Mr. Lindenman wished to have the water conveyed for use and in order to have it so he has purchased a hydraulic ram and will have it in place in a few days. With this he will make the force of the stream from the spring lift a part of the water to the top of the bank and deposit it in a reservoir. This will be the first contrivance of the kind put in in Sioux county, but if it proves successful it is likely that many will follow his example, for there are numerous springs from which the water could be raised to convenient points at but little cost.
—The JOURNAL has received notice that the commissions of Messrs. McLean and Powers as register and receiver of the Chadron land office have been received and it is more than likely that these gentlemen have taken possession of the office by this time. This cannot but be good news to the settlers in the entire district. It is quite certain that when applications for final proof notices are sent in they will not have to lay around the land office for about a month thereby delaying the settlers and putting them to no end of trouble and inconvenience. The office will, in all probability, be conducted on business principles under the new administration, and that is more than can be said of the methods of the outgoing officials.
—On last Tuesday O. P. Haines, the pioneer photographer of this section, arrived in Harrison and pitched his tent just south of the post office and will remain for a short time only. Now is the time for our people to get pictures of themselves and little ones.
