—A good exhibit at the state fair will increase the value of every bit of property in Sioux county, so it is to the interest of all to assist in the work.

—Rev. H. W. Stearns will preach at the church in Harrison on Sunday, Aug. 31st, morning and evening. All are invited to attend.

—The pipes of the water system are being put below frost line. This is an excellent move and will avoid a great deal of trouble during the winter.

—The latest from the locality where so many cows were seen a few days ago is that ten of the animals have been killed, and the farmers are after the rest.

—The date of holding the senatorial convention has been changed from September 11th to September 18th. Notice of the change was received too late for last issue.

—Be sure to bring the best corn, oats, wheat, potatoes, tomatoes, cabbage, melons, and every thing else you have to help make up the exhibit to the state fair.

—A. W. Mohr reports the loss of five calves from the disease known as black-leg and it is said that others have had ill luck from the same cause. It is generally believed the disease can be prevented by proper precaution, but there is no cure for it known.

—At the recent democratic congressional and state conventions the delegates reported as representing Sioux county were E. D. Satterlee, C. H. Weller and John Marsteller. The first named was the only one who was present. No democratic county convention has been held in Sioux county this year.

—For the Corn Palace at Sioux City agents of the Fremont, Elkhorn & Missouri Valley and Sioux City & Pacific Railroads will sell excursion tickets at one fare for the round trip. Inquire of any agent or write to Mr. Jonas M. Cleveland, Sec'y of Sioux City Corn Palace, Sioux City, Iowa.

—We are informed that H. G. Stewart, the alliance candidate for state senator, who is county organizer for the alliance, intends to visit the north part of the county in the near future, for the purpose of organizing the farmers of that locality into alliances.

—A number of Indians from the Pine Ridge agency passed through here on Tuesday for the hunting grounds west of here. They were headed by Red Cloud, at the front of whose wagon floated the stars and stripes, probably to show that he was a "good Indian."

—Remember all the committees on the state fair exhibit are to meet at Harrison on Saturday, August 30th, and everything that is to be used to make up the exhibit should be here on or before that day. It is only a few days until the important must be made and some hard, systematic work must be done by all interested.

—A number of the alliance men of Cottonwood precinct were in Harrison on Saturday for the purpose of organizing here. The intentions of the visitors evidently had not been made known to the farmers of this locality as but few of them were in town, and the result was, that no attempt was made to organize. Another effort will likely be made in the near future, with better success.

—Have you selected any thing to help make up the exhibit at the state fair?

—Having gone out of business, we desire a settlement with everybody owing us, at once. Please remember and act accordingly. Weir & Co.

—Rev. Wm. Wilson will preach at the church next Sunday morning. Come and hear him.

—Bring in a sample of the native grasses which grow in your locality to help make up the state fair exhibit. Bring a good lot of it.

—Don't be at all backward about bringing something for the state fair exhibit. The committees want all they can get.

—Arner's shingle mill was taken out from its place on West Boggy yesterday, and will be set up at once. They expect to be ready to fill orders by the first of September. The first work they will do will be to cut the shingles to cover the log house at the state fair.

—Friday Aug. 23rd, and Tuesday 26th are the days the committee want men and teams to cut the logs from Monroe canyon. Do not wait to be urged in this matter but if possible go there with your team and ax and help get the logs to the depot so that they can be ready in time to load.

—The committee in charge of the preparation of the log house for the state fair exhibit want all the men and teams they can get to go to Monroe canyon tomorrow (Friday) to get out the logs and get them here so that the house may be ready to ship. Take your team or ax, or both, and go to Monroe canyon and help the work along.

—E. E. Livermore killed an animal recently which belonged to the cat family but for some time could not find out just what it was. He brought it to town and C. E. Holmes looked the matter up and found it was a lynx. These are not often seen in this locality, and are not very pleasant things to run across.

—The premiums offered for the best county collective exhibit are cash prize of \$250 and champion silver medal, one hundred copies, one year, of the *Nebraska Farmer*, and one special prize of \$25 for the best and largest collection of native grasses. Certainly that is worth a little effort on the part of each citizen of Sioux county.

—It should be remembered that if anyone has any thing that is good it can be entered in its regular class for premiums in addition to being a part of the exhibit. In case of grains, vegetables, etc., the required amount is not less than one-half bushel. Native hay to compete in class, should be baled and not less than 100 pounds; ear corn not less than fifty ears; corn on stalk five or more stalks. Now see what you can find about your farm that will help make up the exhibit and also do for entry for individual premiums.

—The case of Jas. H. Brookmire & Co. vs. Rosa & Thompson has been taken to the supreme court on error, and after a year or two that court will reach the case and decide it. If the decision of the district court is sustained that will end it, if that decision is reversed the case will be heard again by the district court. The fact that the supreme court is more than a year behind with its work makes it very bad for those interested in cases before it and the amendment to the constitution to increase the number of judges certainly should be adopted so that such long delays may be avoided.

—A letter was received yesterday from Gov. Furnas, secretary of the state board of agriculture, who has been appraised of the intentions of those interested in the Sioux county exhibit at the state fair, in which he stated that Sioux county should have as good a site as there was on the ground. He further stated that the exhibit contemplated was an extraordinary one and should have extraordinary attention by the management of the state fair. Now let all see that every detail is carried out to the letter and if possible let the exhibit be made of such a nature that it will exceed the hopes of the most sanguine.

—The Shay-cattle poisoning case is still in the courts. On Monday Mary Shay had a preliminary hearing before Justice McIntosh, of White river precinct. County Attorney Walker prosecuted and Attorney Elswick, of Crawford, appeared for the defendant. The justice held her to appear at the district court. On Tuesday she was brought up to the county seat by Deputy Sheriff Decker. An application was made for a writ of habeas corpus, and the case was set for hearing on Wednesday but owing to the non-arrival of some material witnesses, the case had to be continued until today and is in progress as we go to press. If the writ is granted it will give the woman her liberty until court commences without bail, and the trouble and expense of keeping her will be saved. If the writ is denied, she will either have to give bonds or remain in custody until court convenes. John Shay has not been arrested as yet.

WILL MAKE AN EXHIBIT.

Sioux County Will be Represented at the State Fair.

The following is the secretary's report of the meeting on Saturday, August 16th to arrange for making a county exhibit at the state fair:

Meeting called to order by Thomas Reidy.

J. M. Robinson elected chairman and G. Guthrie secretary.

On motion it was decided to make a county exhibit at the state fair, but not to organize a county society this year.

On motion it was decided to erect a house on the state fair grounds of Sioux county logs and cover it with native shingles and set Sioux county pine trees around it.

On motion Thos. Reidy, David Bartlett and C. L. Brooks were appointed a committee on log house.

On motion the chair appointed J. A. Green, J. E. Wilcox and Eli Smith to make a collection of grasses, both wild and tame.

On motion B. F. Thomas, A. R. Kennedy, J. F. Schulz and Eli Smith were appointed to have charge of the exhibit, with power to appoint assistants.

C. E. Holmes, S. H. Jones and C. H. Weller were appointed a committee on finance.

C. E. Holmes was added to the committee on grasses.

L. O. Bull, N. L. Pollard and C. E. Holmes were appointed a committee on fossils.

Eli Smith, DeBock and Wm. C. O'Connor were made committee on vegetables.

Geo. Walker, B. F. Thomas and C. E. Holmes were appointed a committee on wood, brick and stone.

On motion C. E. Verity was made general secretary.

Moved that it is the sense of this meeting that both county papers publish these proceedings. Carried.

On motion S. Barker was appointed to take charge of articles as they are brought in.

It was decided that everything to be made a part of the exhibit should be delivered on or before September 1st.

Thos. Reidy, K. P. Lindsey and J. A. Green were appointed to make a collection of wild animals and birds.

On motion adjourned.

—Pursuant to the call published in THE JOURNAL a number of farmers and others interested in the matter of an exhibit at the state fair met at the court house last Saturday afternoon. The meeting was called to order by Sheriff Reidy and J. M. Robinson was elected chairman and G. Guthrie secretary.

The report of the secretary appears in another column. The committees were selected with a view of having those in charge of the various departments who would look after their part of it in good shape. It is to be borne in mind that all the work is not expected to be done by the committees, but the earnest, hearty co-operation of all interested in the future prosperity of Sioux county is expected to be extended to them in the work. Do not wait for a special request to assist, but go to work at once. If you have anything good notify the committee and see that it is delivered here on or before Saturday, August 30th. If you have nothing suitable to bring and know of a neighbor who has, go to him and urge him to bring it and assist him to prepare it. The committee to attend to the log house need a good deal of help. Go to Monroe canyon on the days named and help them with the work. If there is nothing else you can do notify the committee on finance that you will contribute something toward paying the necessary expenses. It is but a few days now until the articles to be exhibited will have to be ready for shipment and there is no time to lose. It would be a good plan for as many of our farmers as can to come to Harrison on Saturday, Aug. 30th and see what has been collected. The reports are coming in from many that they will be on hand with something. Let all join the movement and see what grand results can be obtained. Don't be afraid that what you have is not good enough. Being it in, and being plenty of it. Quantity is next to quality," says Gov. Furnas, secretary of the state board of agriculture.

—The committee of the state fair exhibit want several bushels of nice pine cones delivered here. Do not be afraid there will be too many, but bring in a good lot of them.

—A special prize of \$25 is offered by the state board of agriculture for the best and largest display of native grasses exhibited at the state fair. All the botanists who have visited Sioux county have expressed themselves that the finest as well as the largest variety of native grasses grow within its borders that can be found in the state. All that is needed to win that prize is a little effort. Get every kind of grass you can find and be sure to get plenty of it. It costs nothing but a little labor and will be a great benefit to the county to win that prize. Now is the chance to help your county.
