A Populist Demagogue. Senator Allen of Nebraska is the latest practical exemplification of humbuggery. A few days ago Mr. Allen launched out in a terrific denunciation of the methods, conditions and privileges under which the senate restaurant is allowed to run. It seems that the caterer is allowed the use of the rooms, light and a few other perquisites, while he charges the senators a whole dollar for a sirloin steak with mushrooms.

Senator Allen was terrible and thunderous in his denunciation of the special favor shown the senate caterer. He declared that the American people were being robbed. He wanted the restaurant abolished, with an ultimatum that the caterer either pay rent or charge less for his sirloin steaks. Doubtless the senator (our Nebraska failed to secure a meat budget. But the storm blew over.

A day or two later there was a congressional funeral junket. The remains of Mr. Post were to be sent back to Illinois with the usual congressional escort. Mr. Allen was asked if he would not like to go, and he very cordially accepted the invitation to ride to Chicago at an expense of the country. "By the way," he added "I would like to take my daughter along," and she went, also at the country's expense.

Investigation showed that it is not customary for senators and representatives to take members of their own families along on these free junkets, also that Mr. Allen purchased no ticket for his daughter.

These congressional funeral junkets have been a scandal for many years and it has remained for Senator Allen to bring out a new form of abuse.

The American people endure lots of imposition without objection or even murmuring; but they despise a demagogue and political hypocrite.

Senator Allen, in condemning the senate one day and taking members of his family on a funeral junket at the expense of the nation the next, presents a striking illustration of the demagogery that prevails at the present time among certain populist leaders.

There are many genuine, sincere populists, but they are not of the Allen stripe.
