How many sugar beets are you going to raise this year?

There is no reason why the population of Sioux county should not increase very rapidly after the present season if beets are a good crop this year.

The editor of THE JOURNAL was at Chadron the first of the week and met those interested in the factories to be established there. The people of that city are in the best of spirits for they will now have an opportunity to prosper, such as has not presented itself to them for years.

The committee informed the writer that the contracts would be ready in a few days for the growing of beets the coming season and the other matters will take shape in the near future. The seed will be furnished by the company and is to be paid for at the time of delivery of the beets to the factory.

The company will furnish seedlings and harvesters at a low rental, as is the custom with the other factories, so the only machinery which the growers will need to buy will be such as is needed to prepare the ground and to cultivate the crop. None of that is expensive so that no one need hesitate to engage in growing beets on account of the cost to prepare for it.

The factories are a sure thing and all who are without shipping distance should prepare to grow crops for them as it will be certain to prove profitable. Superintendent Harris has taken the matter of freights up with the department and will get as low a rate on beets to the factory from outside points as he can. It is estimated by conservative people of Chadron that not less than five hundred people will locate in that vicinity by May first. Letters of inquiry are pouring in from all over the country and real estate has already advanced. The same results will be felt in this locality in a reasonable time, especially if all take hold of it and work. A good acreage of beets will help matters very much and will pay the grower.

WHERE WILL IT END?

Outrageous Persecution Conducted Under Pretense of Law.

The dog case wherein Henry Lindeman was arrested and tried for the killing of a dog belonging to Gustav Norresch has made some startling disclosures. It gave the county attorney an opportunity to show that he was a persecutor instead of a prosecutor. The case came on for hearing before Justice Smeek on last Wednesday. A jury was asked for and six men were selected. They took their seats and the trial began. The county attorney produced evidence and when it came time for the defense a large part of the testimony of his witnesses was headed off. The case took all of Wednesday and most of Thursday and the jury retired to consider what they had heard. About two o'clock Friday morning they came into court and wanted their fees before they went any further. As the fees were not forthcoming they brought in no verdict. The county attorney asked that the court order the sheriff to take the verdict from the foreman of the jury and deliver it to the court. The foreman asked to have a little law showing authority for such a proceeding and that settled it. Had such an order been made it would have imposed a nice task on the sheriff, for no verdict had been made up. The result was that the jury was dismissed and the county attorney then moved to dismiss the case. The court did that and then in the taxing of the costs of the case \$19.00 was taxed to the plaintiff and \$31.00 was taxed to the defendant after having been discharged on the motion of the prosecution.

A number of the jurors as well as others have stated that the defense did not show whatever. One of the jurors said that the prosecution failed to prove anything. Taken as a whole it seems to have been the worst piece of persecution ever perpetrated in Sioux county. In the thirty days of bossism when the office of county attorney was used for such strings it could be made to pun more than anything else no such high-handed outrage was committed on a citizen. Taking the case of last week as a sample any person is liable to be arrested and put to the trouble and expense of defending himself in court, and when the county attorney fails to make out a case against him and he is discharged on the motion of the prosecution he will still have a judgment entered against him for a large sum for costs, there is no office in the county which as the power for evil that is possessed by the county attorney. The writer realizes as he writes this that he is liable to be the next victim of his persecution, or it is not the first time that a man arrested has been denied the right of making defense, but it is right that the people of the county know what kind of a person is holding the office of county attorney. Unless care is taken to prevent it there is no knowing when the county will be plunged into expensive litigation by his action and forewarned is forearmed.
