—The jury in the case of Tinnin vs. C. B. & Q. railroad was discharged Saturday morning, having agreed on a verdict of \$3,000 in favor of the plaintiff late the night before. Court immediately adjourned and all those from other towns departed home Saturday. It is hoped that the case above mentioned has been heard for the last time in Sioux county. It was brought here by the attorneys for the plaintiff with the evident object of using the prejudices of the people in the interest of their client. The case has cost Sioux county some hundreds of dollars and the people who have to pay it had no interest in the case whatever. The first trial was long and cost a lot of money but the one last week was still worse. In the latter the jury alone cost \$215 and mileage, and of this the defeated party will pay \$5 and the county will have to pay the rest, as well as the running expenses of the court. It would be a tax-saving plan for the people of the county if they would make the bringing of such suits by outside parties decidedly unpopular in future. The verdict of the jury in the first trial was for \$2,000 and the last raised the amount a thousand dollars, so that the plaintiff has reason to feel good over the result. It would be well for the people to bear in mind that every case in the district court adds to the taxes of the county, no matter whether it be a civil or criminal case.

Complaint has been made to the authorities of boys jumping on and off moving trains and getting in dangerous places about the railroad yards and when Station Agent Pontius tells them to keep off he is insulted. Such matters ought to be taken in hand by the parents. In the first place the boys are liable to get killed or crippled; in the second place the yards, tracks and cars are the property of the company and are under the control of the agent just as much as a store is under the control of a business man, and in the third place some of the boys may get sent to the reform school if they persist in such actions as are complained of. The representative of the railroad company cannot be expected to stand everything.
