—A. H. Pinner died at his home on White river, near Fort Robinson, on Wednesday of last week. He was taken sick on Sunday. A blood vessel in his head burst and caused his death. The funeral occurred on Friday.

—A. G. Fisher and Alvin Clark have formed a partnership for the practice of law. Mr. Clark has been an attorney at Harrison for several years and is a young man of ability and standing. He will move down from that place and take up his residence among us permanently. —Chadron Recorder.

—Those who have received the *Nebraska Farmer* as a part of the premium won at the state fair in 1894 will find the date to which it comes free on the label. The rule of the publishers is to continue to send it unless otherwise instructed and the receiver will have to pay for it after the expiration of the premium year, so that any who do not desire to take it at the regular price should notify them.

—Whenever you hear a man finding fault with his local paper, says the *Steele City Standard*, open it, and ten to one he hasn't an advertisement in it; five to one he never gave it a job of printing to do; even up that he never does anything in any way that will assist the publisher to run a good paper, and forty to one he is the most eager to see the paper when it comes out.

—Christmas passed very quietly in Harrison. The entertainment at the church on Tuesday evening was almost exclusively by the little folks, and as a result was interesting. Two trees were loaded with presents, the distribution of which gladdened many hearts. A number of private trees were fitted up in the residences of the town for the edification of the family, and small dinner parties were numerous. Taken as a whole it was a pleasant holiday.

—In another column appears a call for a meeting of the stock owners of Sioux county to meet in Harrison to further perfect an organization to protect their interests. Rustlers and wolves are making heavy inroads into their herds and in the effort to check it every honest man who has the welfare of the county at heart should lend whatever aid he can. It is to the interest of every taxpayer of the county that rustling be stopped before a killing grows out of it and the county has an expensive trial to pay for.

—THE JOURNAL received a letter the first of the week from O. J. Gowey and also samples of fine dried fruits grown where they are located. They are near Emmett, Ia., in the Payette river valley. Crops are irrigated, there is no outside range except in the mountains and that is occupied by sheep men. Hay is from \$5 to \$10 a ton and other things about the same as here. Horses have no value at all, a sound, young horse would not sell for \$10, and half that price in trade. He says Sioux county is the best stock country he ever saw and he has traveled a good deal. He and his family are well and while nothing is said of returning he does not think they are as rich as they would have been had they remained here.

—Several stock owners report the loss of cattle recently and attribute it to rustlers. THE JOURNAL hopes that they are mistaken for the less are owners of small herds and not cattle barons, and if rustling is persisted in some one will get into trouble and the taxpayers of the county will have to pay a big bill of costs. It is the general sentiment in the county that the expense of no more farces should be put upon the county, but it is also the sentiment of all honest people that a stop should be put to cattle stealing. There are many who did not say anything against preying upon stock belonging to outside owners which had drifted in here, but to take stock belonging to the owner of a small herd and who lives in the county, puts the matter in quite a different light. Honesty is the best policy for all.
