In our opinion, there is no reason why the three parties should not be united against the common enemy of the three parties. If the united efforts of the three parties last fall brought good results what good reasons can there be against the same effort this fall, of course any disunion that could be brought about by the Republican party in the ranks of the three reform parties would please them mightily. In union alone there is strength therefore union of the three silver forces this fall means a sweeping victory for Sioux County and the state of Nebraska.

A TRINITY THAT WILL WIN.

Lincoln, Neb. July 10.—That meeting of the representatives of the democratic, Populist and free silver republican parties in this city on last Thursday, when the state committee assembled, settled one question and proved untrue the claims of the republicans that there could be no uniting of free silver forces for the fall campaign. Sixty populists, half as many free silver republicans and as many democrats, who gathered from all parts of the state in their respective state committees, working together in complete accord was a sight to give the cold shivers to republican politicians whose only hope has been the fomenting of discord. The fact is as plain as the nose on the average face that the free silver forces do not have to be harmonized because there is harmony and unity of action already so far as 99 per cent of the whole mass is concerned. The republicans see with dismay, and the leaders do not attempt to conceal that the effort to bring about disunion, carefully fostered as it has been by their papers and workers, has been barren of any other result than that of drawing the opposition to republicanism closer together. The greatest convention ever assembled in the state of Nebraska for the naming of candidates for state officers will be that of September 1, when the three conventions meet. There will be a determination on the part of the delegates to each of the three, to name the men who will be elected, and they will do it.

BOSS HANNA'S SCHEME.

He Will Endeavor to Carry Nebraska Against the Democrats and Populists This Fall.

WASHINGTON, July 2.—Chairman Towne of the Silver Republican national committee has discovered that the Republicans, under the leadership of Hanna, are resolutely determined to carry Nebraska against the Democratic and Populist combination this fall. "The purpose of their desperate effort to carry Nebraska will be two-fold," said Mr. Towne to the News representative. "They need something to meet the almost certain loss of Ohio this year. If the Republicans were to carry Nebraska it would cause a great rallying from the depression following the Ohio defeat, and be a very clever piece of politics. "As a matter fact, though," said Mr. Towne, "they will not win. We shall beat them hard though, in Nebraska also. One thing they have in mind is the hope that Democratic defeat in Nebraska will centralise Bryan's popularity. It will have no such result. He is all right, and whatever happens in Nebraska, he will be nominated and elected 1900."—Denver News.

STAYS MOUTH OF TRUTH.

THE ARGENTINE REPUBLIC.

Some of the salient and interesting features of that Central Government. The constitution of the Argentine Republic is, in its features, identical to that of the United States, says Don Juan S. Attwell in the New England Magazine. Nevertheless there are some differences worthy of note. The president is elected in precisely the same manner as in the United States, but cannot be re-elected, and his term of office is six years. He has more power than the president of the United States as far as making appointments is concerned, since he only asks the advice and consent of the senate to appoint diplomatic ministers, judges and officers of the army and navy above the rank of colonel. He fills all other offices at his own discretion, but all his decrees, proclamations, etc., must be countersigned by a cabinet minister or else they are valueless. Thus the constitution makes the cabinet ministers responsible for all the acts of the president. The members of the cabinet can answer questions and take part in the debates of the house and senate, although they are not members of either body, nor does any adverse vote on any measure of the government carry with it a change in the cabinet, as is the case in France and England, and is becoming the custom in Chile. The powers of the Argentine congress are similar to those vested in the congress of the United States, though somewhat greater. The congress has the power to legislate for all the provinces, dictating codes to be applied in all of them, thus securing uniformity of legislation. The provinces reserve the right to elect their own judges, as well as other officials that their local constitution demands. All federal and provincial judges are appointed for life and cannot be removed unless they are impeached and condemned.
