minute before, when a bolt of lightning  
which struck simultaneously the Jour-  
nal office, Bank, Post Office and Mar-  
stellers Bros. store a portion of which  
bolt came down the front door and win-  
dow casing of the bank, struck Mr. Dew  
killing him instantly and stinging Homer  
Priddy quite seriously; though he will  
recover in a day or two no doubt. The  
great wonder is that four or five others  
were not killed as there were at least  
4 or 5 more men just inside the post  
office probably ten feet from where Mr.  
Dew and Mr. Priddy were standing  
when struck. In Marsteller Bros. store,  
at least half a dozen men were in  
reading the evening papers and discuss-  
ing the war news when a part of the  
same bolt came through from the ad-  
joining building (post office) about mid-  
way of the store building shocking every  
body in the store, setting fire to paper  
goods on the shelves, melting holes in  
the can goods setting near by.

mittees from states having no Democratic  
senators or congressmen. He did it un-  
der authority of a resolution of the com-  
mittee. He has taken pains that only  
good reliable Silver Democrats has been  
named. He has chosen Major Henry  
Fulton of Boulder member for Colorado;  
R. Z. Johnson of Bois for Idaho and John  
H. Dennis for Nevada.

Hon. James H. Kyle is the great pol-  
itical acrobat of the senate.
