Rohwer as Brand commissioner was on motion rejected; the claim of State Journal Co. for vouch-er Record, was on motion rejected for the reason that the purchase of same was not authorized by the clerk and the record ordered returned. The official Bonds of Frank Tinkham as Deputy Sheriff and Perry White as Road Overseer in Dist. No. 12, and Pat Lacy as Road Overseer in Dist. No. 3 were presented and on motion approved. Roady's arrears annual settlement of Jas. McCann was presented and approved and on motion certificate ordered drawn on Road Dist. No. 4, for same. The Road Petition of Walter Pitts of asking that county road be located; commencing at the half section corner on Township 21 and Range 55, running thence west and south across the military wood Reservation, thence west in the most practical road to intersect with county road No. 36 at the north-east corner of Section 18 in Township 21 Range 55, was taken up and after due consideration the Board find that the road petitioned for is a consent road, and on motion the same be and hereby is declared to be a public road. The road petition of John Lacy et al asking that a county road be established, commencing at the north-east corner of Section 14, Township 21, Range 57, thence south on Section line between Sections 14 and 14 to the north-east corner of Section 23, thence diagonally across the north half of Section 31 to a point on correction line 80 rods south of the north-east corner of Section 24, Township 21, Range 57, thence east one and one half miles to a point 80 rods north of the center of Section 20, Township 21, Range 57, thence south 80 rods thence east to half section corner between Sections 20 and 21, thence south 80 rods, thence east to a point 80 rods south of the center of Section 21, Township 21, Range 57 and intersect with what is known as the Monroe creek road. After due consideration the Board find that the road petitioned for is a consent road and on motion the same be and hereby is declared to be a public road. On motion Board adjourned till 7 a. m. Call for People's Independent Party County Convention.

A delegate convention of the People's Independent Party will be held at the county court house on Saturday, July 12, 1898, at the hour, 1 o'clock p. m. at the court room in said court house for the purpose of selecting 4 delegates to attend the Congressional Convention to be held at the city of Broken Bow on the 14th day of July, 1898, and for the purpose of selecting 3 delegates to attend the State convention to be held at Lincoln, on the 2nd day of August next, and for the purpose of deciding whether delegates for the Representative and Senatorial conventions be selected or whether another convention be called for that purpose; and also for the purpose of transacting such other business as may be properly brought before the convention.

The representation to said convention is based on the vote cast for Hon. Judge John J. Sullivan, for supreme judge at the election of 1897, and the apportionment will be one delegate for every 10 votes or fraction thereof.

The various precincts in the county are entitled to the following number of delegates:

It is recommended no proxies be allowed, but delegates present will be allowed to cast the full vote of the delegation of the precinct.
