CAPTURED BY HANNA.

THINGS COME HIS WAY IN THE CONVENTION.

Governor Bushnell and All the Present State Officers Re-nominated by Acciamation-Brief Speech by Hanns -Tenor of the Resolutions Adopted.

Ohio Republican Convention. Tolepo, Ohio, June 24.-United States Senator Hanna completely dominated the Republican state convention, routed Senator Foraker and Governor Bushnell in the contest for the state chairmanship and secured the strongest indorsement for both shat

and long terms as senator. Governor Bushnell, who had made so strong a fight for Charles L. Kurz for state chairman as to even threaten to decline a renomination in the event of Kurtz's defeat, changed his mind after several conferences with Mr. Hanna and other party leaders, and this morning accepted the renomination which was tendered to him unan-

This morning the convention proceeded promptly with the usual business. The report of the committee on credentials was adopted without opposition as it made no material difference in the control of the convention, which was overwhelmingly with Senator Hanna. The temporary organization with General Grosvenor in the

chair was made permanent. The committee on resolutions was in session all night trying to frame the platform so as to prevent a contest in the convention on the civil service, Cuban and other resolutions.

The platform as presented opened with an expression of rejoicing at the victory last year of "an honest dollar and a chance to earn it," and continued: "The platform upon which that victory was won declares the true principles and policy of the Repub-lican party. To all the declarations of that platform we pledge anew our allegiance and unqualifiedly commend the President and Congress for their wise and statesmanlike execution of

its pledges. 'The Republican party has always been the friend of the downtrodden and oppressed and has always deeply sympathized with the struggle of any people for independence. We extend our sympathy to the patriots of Cuba in their efforts to achieve freedom from Spanish cruelty and oppression and hope that the day of their deliverance is near at hand. We commend the course of the president and express our confidence in his speedy and patriotic disposition of the Cuban question in accordance with wise statesmanship and a firm and vigorous policy.

"We believe that the administration in negotiating the treaty for the annexation of Hawaii has acted wisely and we express the hope that the Sen-

ate will ratify the same. "We denounce the violation of the spirit of the civil service act by President Cleveland in those orders which extended its operation beyond its purpose and intent and demand such revocation of orders or modification of the law as will accomplish its manifest purpose."

MR. HANNA SPEAKS.

The reforms inaugurated in the pension bureau under the present administration are commended and the passage of a national arbitration law, demand ample protection to wool and indorse Governor Bushnell and both Senators Hanna and Foraker.

The mention of Senator Hanna's name was greeted with loud demonstrations, and after the resolutions were adopted he was called for.

He thanked the convention for this expression of confidence and pledged himself to co-operate with the standard bearer (Bushnell) for Republican success in Ohio. He said the Republicans had been warned that this was a dangerous year. He joined in accepting the challenge. The Republicans of Ohio always fought best when there was danger ahead. The opposition proposed to stir up the once threshed straw. They would revive free silver in Ohio, but never free wool. He discussed the pending tariff bill at length and paid a high tribute to General Grosvenor for his work in the House of Representatives for protection. He said he was now trying in the Senate to keep up with General Grosvenor's pace in the House. He paid the highest tribute to President McKinley's efforts to bring about prosperity and the best possible conditions for the country. 'the President ad many difficulties to overcome, but he would meet the predictions of his friends and the hopes of everybody.

BLACK FLAG IN IRELAND.

Parnellites Parade Dublin and Smash Windows of Illuminated Houses. LONDON, June 24 .- The jubilee was

celebrated in almost all parts of Ireland with enthusiasm, by public offi-cial fetes, decorations, illuminations and bonfires. The Parnellites, however, were very busy with counterdemonstrations.

In Dublin, a procession went through the streets carrying a black flag and a coffin labeled "The British Empire," and smashing windows of illuminated houses. The city has not been so thoroughly excited since the death of Parnell. Last evening a large meeting was held in the Dublin town hall in memery of the rebellion of '98, and speeches were made glorifying the men who were the heroes of that movement.

At Cork the National Society hung out black flags and attempted to hoist one on the municipal flagstaff, but the police interfered.

At Limerick, the police removed black flags from the town hall and from a number of public monuments. During the evening John Daly addressed a small hostile demonstration. As against this, the royal Irish regiment held a military tattoo, and there were several torchlight processions, in all of which large numbers of citizens participated.

Smul len of St. Helens Onger, in Essex, England, who, they allege, has renounced all claim to the estate in favor of the rightful heirs.

EXPERTS ARE HEARD.

THEY GIVE TESTIMONY IN THE BARTLEY CASE.

Mr. Bartley's Last Biennial Report Of fered in Evidence-His Personal Accounts in the Banks-How Much Was on Hand April &, 1895 -As to Disbursements.

Progress of the Bartley Case. At the opening on the eleventh day of the Bartley trial the state offered in evidence that portion of Bartley's last biennial report, including the sum-mary of the statement of funds, the prosecuting attorney stating that this was introduced for the purpose of showing that the \$236,361.83 of the sinking fund which was tied up in the Capital National bank, was deducted from the balance of the sinking fund, thereby showing that the money was not carried in the balance, as claimed by the defendance. by the defense. The offer was admitted in evidence and read to the jury, the report stating that "the amounts tied up in the defunct banks" had been deducted in making the balances, and then followed the items of these deductions, including this item. "In the Capital National bank, \$236,-\$61.83."

Bookkeeper Adair of the Omaha National was called to the stand and questioned regarding Bartley's personal account in that bank. He identified the continuation of this account and the state offered in evidence the credit side of the account for the purpose of showing that in addition to the \$180,101.75 realized from the warrant, Bartley also deposited other large sums to his personal account in the Omaha National, rebutting, as the county attorney claimed, the presumption that the \$180,101.75 had been all transferred to other banks and thence back to the

The defense contested the admission of this evidence, but the court ruled that it was admissible, and it was read

The state, in introducing evidence, called Otto Helbig, who testified that he had been employed as an expert in checking the books of various corpora tions, which he named, during several years. He said he had been employed in checking up the books in the office of the state treasurer, commencing the work April 26, of this year, under the direction of the legislative investigat-ing committee, the examination being completed June 8. He had checked all the records in the office showing all the receipts from April 1895, to January 6, 1897, the end of Bartley's term.

The witness testified that Bartley

had on hand in the general fund April 1. 1895, \$98,116.12. The receipts to the general fund during the period be-tween April 1, 1895, and January 6, 1897, were \$426,674.18.

The witness was then asked to state the disbursements during the same period from the general fund. He answered that the disbursements were \$1,105,574.77. The balance in the general fund at the close of business on June 6, 1897, as shown by the records, was stated to be\$419,215.53. The witness was then asked to state the sum of the amount on hand April 1, 1895, and the balance on hand June 6, 1897. He made the computation and stated that the total was \$1,524,790.30. Tak ing the disbursements from this amount the witness stated that the balance was \$419,215.53, being the same as the balance shown by the

BARTLEY IS GUILTY.

Conviction on the Third Count in the

Information Charging Conversion. Omaha Bee, June 23: The Bartley jury reached a verdict at 10:05 o'clock Tuesday morning, after being out since 5:30 p. m. Monday. The verdict found the defendant guilty, as charged in the third count of the information. of converting the money of the state to his own use as an individual while holding the office of state treasurer, the amount of the embezzlement being fixed at \$151,884.45.

After the verdict was read by Clerk Frank the jury was polled at the request of the defendant's attorneys, and each member of the jury, as his name was called, answered "yes" to the question, "Is this and was it your ver dict?"

The defendant has three days within which to file a motion for a new trial and the hearing on this motion will undoubtedly be had before court ad-

journs for the term. In case the motion is overruled sentence will passed, and this will unquestionably be followed by an appeal to the supreme court. It was learned that on the first ballot after the jury retired Monday night the jury stood nine to three, the three being for acquittal. The last ballot yesterday morning, before a verdict



The amount of money which Bartley is convicted of embezzling was prob ably seached by giving Bartley credit for the \$50,000 which he claimed to have checked into the general fund from his private account in the Omsha National bank. The amount of money he was accused of embezzling was 8201.884.05 and it appears that a slight error was made in the computation, making the figures in the "cents" column "45" instead of "05."

After the verdict of the jury had Baker issued and order releasing Bartley's bond for his appearance in court and remanded him to jail to await sentence. This proceeding was some-thing of a surprise to the defendant and he promptly took an exception to the order of the court, but Bartley was turned over to Sheriff McDonald and about noon he was taken to the jail and placed under the charge of the jailer. He was accorded the same jailer. He was accorded the same treatment as was given Henry Bolln, the Omaha ex-city treasurer, who left the county jail a short time ago for the state penitentiary to serve a sentence of nineteen years, passed upon him by Judge Baker for the same crime for

which Bartley now stands convicted. A telegram was sent to C. O. Whedon, one of Bartley's attorney's, who lives at Lincoln. What will be the next move of Bartley's attorneys can only be conjectured, as Mr. Mahoney refused to divulge anything in connec tion with the matter. It is surmised, however, that proceedings will be commenced to secure Bartley's release from jail, pending action on the motion for a new trial.

The section of the statute under which Bartley stands convicted provides for a sentence of from one to twenty-one years and a fine of double the amount of the embezzlement.

Crop Bulletin for Week Ending June 21



The past week has been a very warm one: the daily mean temperature has averaged 5 degrees above the normal the excess varying from 2 degrees in the western sections to 8 degrees in

the Missouri valley.

The rainfall has been about normal in the central counties and below the average in the extreme eastern coun ties and in that portion of the state west of the one hundreth meridian.

The past week has been another favorable one for the growth of corn; the crop has pushed forward rapidly, but continues small for this season of the year. Much of the corn has been cultivated the second time and the corn fields generally are very free from weeds.

small grain in most parts of the state. In the greater portion of the eastern sections, except in a few southern counties, the oats have been injured by drought, and a full crop will not be harvested. Spring wheat has also been somewhat injured. Oats and spring wheat are heading with very short straw. Rye and winter wheat are nearly ready for the harvest. Rye is generally an excellent crop. Wister wheat is very uneven. The first cut-ting of alfalfa is nearly completed; an excellent crop and generally harvested in good condition.
