The measurements of the rivers of Texas by the hydrographers of the United States geological survey have brought to light the fact that during 1900 there was a marked increase in all the streams investigated. This was found to be particularly evident in the streams which rise in the extensive Edwards plateau. The Edwards lateau is a flat tableland in south ntral Texas some 2,000 square miles area, the extension of the high ins of western Kansas.
