Math Department Asks End of Bias

NASHVILLE, Tenn. (ANP)-The Fisk university mathematics department last week requested the nation's two important math professional associations to amend their by-laws to exclude segregation and discrimination in both organizations.

In a letter to the executive boards of each body, the Fisk professors requested the American Mathematical society and the Mathematical Association of America adopt new anti-bias

The letters were an official protest to the March 16-17 meeting of the southeastern region of the Association at Peabody Teachers college and Vanderbilt university in Nashville.

On this occasion the arrangements committee cancelled four reservations made by the Fisk department because Negroes were included in the group.

Signed by Lee Lorch, associate professor and chairman, Evelyn Boyd, associate professor; H. M. Holloway, assistant professor, and Walter Brown, assistant professor, and Walter Brown, assistant professor, the letter said

"The Fisk mathematics department hereby requests the American Mathematical Society and The Mathematical Association of America to insert into the respective by-laws of the two organizations explicit and effective protection of the rights of all members to participate fully, freely and equally in the affairs of the organizations without regard to race, creed or color.

"It should be stated flatly that meetings, and teas, receptions. luncheons, dinners, etc., associated with meetings, shall be held only at institutions, hotels, etc., where prior assurance is given that there will be no discrimination.

Want Ruling on Jimcrow Schools

KNOXVILLE, Tenn. (ANP)-Dissatisfied with a recent federal court decision that ruled in favor of four Negroes seeking entrance in the all-white University of Tennessee's segregation laws il-

It appears that they are appealing a decision in their favor to the U.S. Supreme court to demand action on the question of jimerow schools. Robert L. Taylor already ruled in their cases that the university would have to admit them on the basis of their applications, and not their race.

He did not deem the subject of segregation appropriate in this

In the meantime, the state of Tennessee is thinking of whether or not it will appeal Judge Taylor's decision, too. The state does not want Negroes to attend the university at all.

If this case does reach the high court on both appeals, it will be one of the rare instances that any court has heard a case appealed by both sides involved.
