CHICAGO, April 17.

After the destruction of the white settlement at Spirit Lake by the Sioux Indians, they attacked Springfield in the southern part of Minnesota, but were repulsed with a loss of 10 or 12. A detachment of 100 government troops pursued there, but being without provisions, they were compelled to return.

The Attorney General of the United States has decided that the removal ot the capital from St. Paul to St. Peter conflicts with the organic law of Minnesota, and is therefore, void.

It is rumored that Sam Houston will be a candidate for the Governorship of Texas in opposition to the Democratic candidate.
