Legislature of Nebraska Territory approved January 25, A. D. 1856.

An act for revising, consolidating, and preparing a general code for the Territory of Nebraska...

Act 2.—The business of this corporation shall be, and has the power to construct and build a Rail Road with double track...

Act 3.—Said Company shall have the power to make, adopt and amend its rules and regulations as the interest of the Company may require...

Act 4.—Said corporation is hereby authorized to lay out their said Road one hundred feet wide, the whole length, and for the purpose of cutting embankments, stone and gravel...

Act 5.—The capital stock of said Company shall consist of five millions of dollars, to be divided into shares of one hundred dollars each.

Act 6.—The Board of Directors shall be elected annually, in accordance with the rules and By-laws of the Company...

Act 7.—The said corporation shall have the exclusive power and privilege of building a Rail Road between the points before mentioned...

Act 8.—That any person or persons, maliciously, wantonly, or willfully damaging or destroying any property belonging to said Company...

Act 9.—The Board of Directors shall fix the time and place of holding the annual election and regular meetings of the Board and Company...
