The following is a list of delinquent State and County Taxes, assessed upon real property in Nemaha County, Nebraska, and remaining unpaid on the First day of December, 1870, and also a list of the delinquent lands and lots upon which the taxes remain due and unpaid in said county, and the total amount due thereon for each year, and the year or years for which the same is due.

Notice is hereby given that in order to enforce the lien of such taxes upon the real property on which they are assessed with interest, penalties and costs, the undersigned, A. H. Gilmore, County Treasurer of Nemaha County, Nebraska, in tends to apply to the District Court of the First Judicial District, in and for said county, at the Next April Term thereof, for judgment against such delinquent lands and lots for said taxes, and interest, penalties and costs, and for an order to sell lands and lots for the satisfaction thereof.

And notice is further given, that on the Fourth Monday next succeeding the First Monday of April, 1871, (said First Monday of April being the day fixed by law for the commencement of such term of the District Court,) to-wit:

On the Fourth day of May, 1871, all the lands and lots, for the sale of which an order shall be made, will be exposed for public sale at the building where the Court shall be held in such county, to-wit:

At the Court House, in the City of Brownville, in said Nemaha County, for the amount of taxes, interest, penalties and costs due thereon.

Such sales will be between the hours of 10 o'clock A. M. and 4 o'clock P. M., and will be continued from day to day until all the tracts or lots in the delinquent list shall be sold or offered for sale.
