THE ELECTION. It is very difficult to get definite figures from any part of the State, yet enough has been heard to know that the Republican State ticket is elected by at least a 3,000 majority.

Saline county gives 100 Democratic majority. Merick gives a small Republican majority, except for Butler.

Hall county gives about 75 Republican majority, with Butler only ten behind. Buffalo county gives ten Democratic majority.

Otoe county has elected Brown, (Republican), to the State Senate, and one Republican Representative. The Republican State ticket has a small majority.

Richardson is reported to have elected the Republican county ticket, and given Butler and the State ticket 400 majority.
