Artificial Sansage-Skins.

During the recent war in Europe, so great was the demand for sausage-skins that recourse was had to a substitute.--- An ingenious French invention is a machine for writing music. The inven-tor passes over a metal cylinder, turning The Berlin pea sausage factory for some regularly by means of a clock movement time consumed daily a hundred thousand and communicating with a battery, a skins; but soon the supply began to run short, and parchment paper was sug-gested as a substitute. The difficulty in the use of this material was to paste the edges of the paper containing the sausage and other systems. The clock move together, ordinary paste being useless for this purpose. Dr. E. Jacobsen, howev cr. prepared a paste which kept the edges firmly united after several hours' placed on the cylinder, the inventor pounds were used for pasting sausages. 
