Dawes gained on every ballot but Nance gained faster than he, and reached the coveted goal far in advance of his competitors.

Mr. Wigton, who was defeated in the gubernatorial election of the year 1876, should be eligible to re-consider his views on having had much experience with the school laws of the state in his county superintendency of 1876-77. He should be able to maintain the best state of affairs of day, with the positions, and especially Mr. Scofield may thank Wagon Co. for their persistence, and now may the republicans have the chance of the man of their session by coming up to the point and voting for "straight" ticket.

At the judicial convention at Kearney last Thursday, J. D. Hastings was nominated for the 24th Fallot. Our Gilliam and Collins of Kearney were the strongest contestants, their forces being about evenly matched. At last, being able to afford no honorable compromise, our boys turned in and nominated Scofield as a position which we hope to see filled with ability if elected. Mr. Wigton only entered the race at the very earnest solicitation of his many warm friends and the manner in which he lost will give him more friends than would his success have done. As a county we feel proud of every young senator, and the hearty support he received in the convention and his large and increasing practice in his chosen profession, in which he has been eminently successful, justifies this pride and gives it a firm basis.

The convention have done their work, and the State, Senatorial, Judicial and county ticket is at our mast-head. Though the ticket is not exactly what we look for, yet the men selected are all as far as we can ascertain, able, worthy and efficient; and as such are entitled to our support. The holding of nominations is not as a rule judicious, and heretofore has been unsuccessful, except in local elections where no important interests were involved. The ticket as it stands is worthy the support of all honest republicans and we hope to see the entire ticket elected.

Mr. Burton the greenback nominee for county commissioner is well known as an intelligent farmer and school teacher, but Cray the republican nominee, is a man of marked ability and also a farmer. Republicans remember that Mr. Cray is the republican nominee of the convention and should give a prior claim to your vote. We have no objection to Mr. Burton, but the republicans with their true sense pick show a better and surer means of increasing the credit of the county without impairing the nation's credit, than the party with whom he identifies himself.
