Commissioners Proceedings.

The county board of commissioners met in regular session October 3, with all members and the county clerk present. Geo. Van Woert appeared before the board and requested board to furnish new blade for road grader for Guide Rock precinct. Matter referred to J. Vance.

Motion carried that the treasurer is authorized to sell lots 19 and 20 in block 21, Smith & Moore's addition to Red Cloud at private sale for \$10.00. J. S. Gilliam, attorney for Jno. Sorenson made a proposition to board to deed the right of way for a road between sections 31 and 32 1/2, Cather-ton, which was upon motion rejected.

Jerome Vance was instructed to build two bridges between sections 27 and 34, and 26 and 33 1/2. W. J. Vance made complaint against closing creek between section 35 in In-avale and section 2 in Walnut creek precinct. Matter referred to Wm. Irons.

E. U. Overman appeared before the board and asked for more time in taking up the road case of Webster county vs Harry McCormick. Request granted and matter laid over until next meeting of the county board. Board adjourned to meet at 9 a. m. October 4th.

Board met October 4th pursuant to adjournment with all members present. Committee appointed at last meeting to report on petition of W. H. Huffman and others regarding the building of an iron bridge across the Little Blue reported recommending that the old bridge be repaired and that the petition be granted as prayed for as soon as funds will warrant. Report approved.

County clerk was instructed to draw county warrant for \$54.60 to road district No. 37 from county general road fund. Petition of Thos. Roden to open road between sections 5 and 6-2-12, also commencing at the southeast corner of section 6-2-12 referred to Wm. Irons and E. B. Smith.

I. W. Edson presented warranty deed to Webster county for land for road for which county agrees to pay \$35. Clerk was instructed to draw warrant for that amount and record deed. Wm. A. May was authorized to do the grading up to bridge in Potsdam precinct, at corners of sections 8, 9, 16 and 17.

Petition to the voters of Webster county to submit to a vote of said county at the next general election to be held therein, the revocation of the law now in force in said county for the granting of bounties for the destruction of wild animals, was presented and granted as prayed for.

Reports of Eva J. Case, county superintendent; J. P. Hale, county clerk; Jas. Burden, clerk of district court and E. W. Copenlen, superintendent poor farm, were examined and approved. Moved and carried that when John Sorenson signed his right of way for road between sections 31 and 32 1/2 the county clerk be authorized to pay him county warrant for \$60; also to deliver to him county warrant for \$40 now in his office, in consideration of the right of way of said premises.

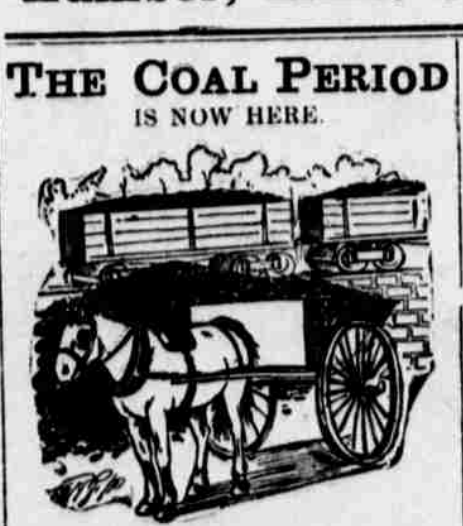
