### **Douglas County Taxes**

Undergo Big Reduction Lincoln, Aug. 4.-(Special.)-The 33 1,3 per cent reduction in the state tax levy made possible by reductions of appropriations at the special ses-sion of the legislature will save Douglas county taxpayers \$374,097.48 this year, according to figures compiled in the office of W. H. Osborne, state tax commissioner.

Last year state taxes collected in Douglas county Imounted to \$1,180,-981. This year they are reduced to \$816,883.52.
