

Secret Factory Flooding Paris With False Arts

Police Scour Latin Quarter but Fail to Find Source of "Masterpieces."

Paris, Sept. 23.—A mysterious hidden studio which is, in reality a veritable factory for turning out counterfeit masterpieces, is the object of search by prefecture detectives.

This factory is somewhere in the Latin quarter. There poor students and starving artists, it is believed, are paid too tempting wages for copying the works of great painters, and the originals of which would command high prices. These copies are then sold at auctions either deliberately in place of the original, which may be in a private collection, or as a "newly discovered" work of the master.

Discovery of such "art treasures" on the market has led to the belief in the existence of this "masterpiece factory," and to the combing of the Latin quarter by the police in search of it.

In particular, spurious works of modern painters of note have been detected, a variation of the old game of counterfeiting the old masters. All of the counterfeits discovered so far have been signed with the painter's name, cleverly forged.

Thomas Knock, an American art connoisseur, was the first to put the police on the track of the swindlers. Knock recently paid \$300,000 francs for a collection of 107 pictures.

Out of this group of pictures an expert picked 45 counterfeits. Among them were works by Coran, Elgar, Matisse, Renoir, Signac, and others, representing for the most part a popular modern school of painting, the works of which bring high prices.

A celebrated art critic whose name was not permitted to be published was another victim of the "factory."

Police plan, they say, to investigate every art dealer, and many of the studios, on the left side of the Seine. Already, they say, they have discovered a group of bad imitations of works of Coran, Elgar, Matisse, Renoir, Signac, and others. But the whereabouts of the suspected "factory" remains a mystery.

Contracts for Trees in Happy Hollow Let

Contracts have been awarded by George & Co. for setting out trees this fall in the new addition to Happy Hollow circle, which is just north of Happy Hollow club on the west side of Happy Hollow boulevard.

Arrangements have also been made for extending the Happy Hollow ornamental lighting system on this tract. This work will be done this fall.

Although practically none of the public improvements was in at the time this tract was put on the market last spring George & Co. announce a third of the lots have been sold, all of them for building purposes. One \$25,000 residence is now nearing completion in the district and another high-priced house has been started.

Public improvements that now are in consist of water, gas, storm sewer, sanitary sewer and sidewalks. It has not been determined yet whether the district will be paved this fall or next spring.

Shuler & Cary Firm Starts

Grading on New Tract

Shuler & Cary last week started grading operations in the 30-acre tract on West Pacific street, known as the W. A. Ryan land.

This tract is on the south side of Pacific street and is joined to the west by Loveland, that portion of A. J. Love's farm which was put on the market last spring by Shuler & Cary.

This tract will be the third unit of the West Pacific development district. The development will be similar to that of Loveland and Ridgewood, Ridgewood having been put on the market last spring also.

The Ryan tract has a number of trees on it, nearly all of which will be left standing. The ground will probably be new on the market in about 30 days as country home sites, acre and one-half sites.

The Ryan tract is all high ground at the crest of the hill which lies west of Elmwood park.

Real Estate Business

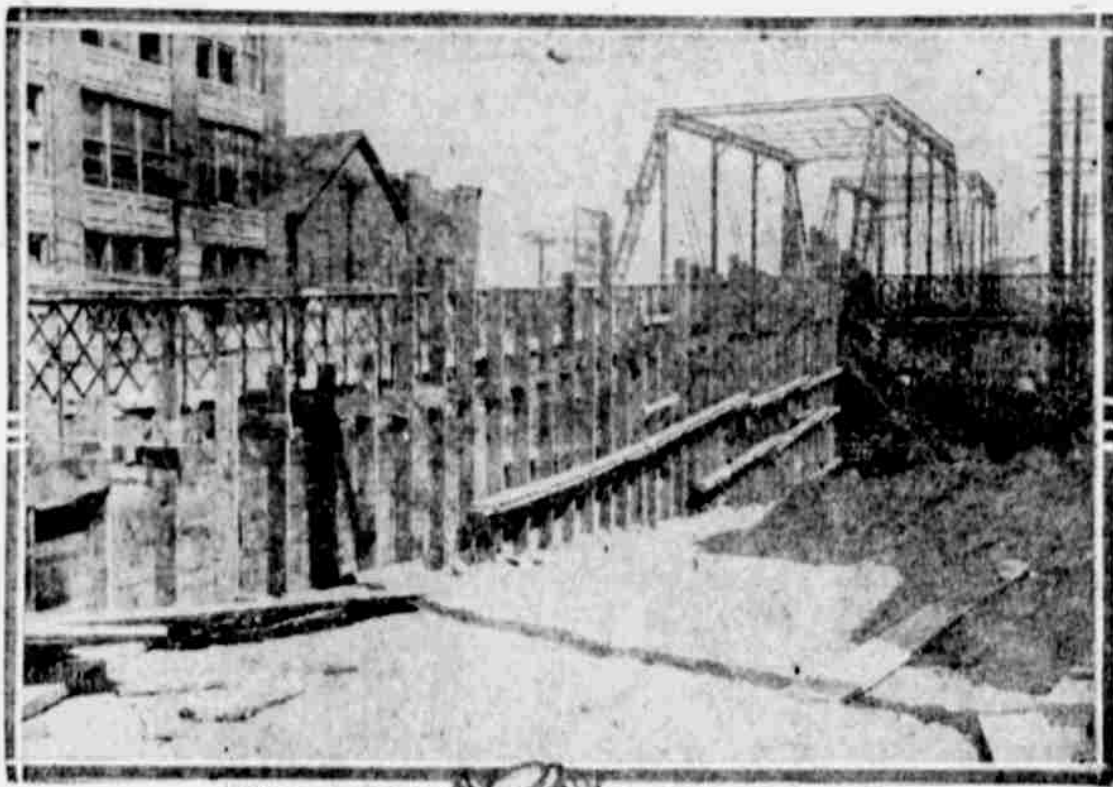

Bridge Improvement Under Way



Work of widening and strengthening the Douglas street bridge across the Missouri is well under way. The bridge is to be 16 feet wider, to make room for double street car tracks, a road on each side of the tracks and a eight-foot walk on the north side of the bridge.

A third row of piers is being sunk to strengthen the structure. Work should be completed between May 1 and July 1, next year, at a cost of \$700,000, K. A. Leussler, general manager of the Omaha & Council Bluffs Street Railway company, said.

Hastings to Inspect Big 26-Acre Tract

Byron R. Hastings, president of the company which last week bought the big 26-acre tract on West Dodge street, today will make a personal inspection of the entire tract.

This does not mean that Mr. Hastings will simply look at the land. He will walk all over it, through the corn fields, alfalfa pastures, trees, etc. He will walk up and down every creek and ravine and over all the hills.

"Our engineers will tell us all about all of this land after they make their surveys and when they make reports for the development work which we intend to do," Mr. Hastings said, "but I want to see it all myself, and the only way to get through it is to walk. Before we start our development work I intend to know everything about this land."

Mr. Hastings' firm, Hastings & Heyden, hopes to start at least a portion of their development work this year, although it will require several weeks to make surveys and detailed plans.

Mr. Hastings says that one man has already asked to buy some Dodge street frontage as a garage site. The request was denied, however, owing to the fact that no selling plans had been made or will be made for several months.

Anheuser-Busch Land Platted Into Lots

The three-acre tract of ground at the southeast corner of Thirtieth and Fort streets, owned for several years by the Anheuser-Busch interests, has been platted into 18 lots by the American Security company and will be put on the market next Saturday, September 30.

This tract of ground contains many large trees and is improved with water, sewer, gas and sidewalks, paved on both Thirtieth and Fort streets. The lots will be 40x120. It will be sold on easy payments. Several years ago this ground was used as a beer garden, the Anheuser-Busch people refusing until now to permit its development as residence property.

Hastings & Heyden Markets 29 Lots in North Benson

The demand for buildings lots this fall has caused the firm of Hastings & Heyden to put on the market today 29 lots in the north part of Benson, which had been intended to hold until next spring. These lots are located at Sixty-sixth and Pinkney streets.

Hastings & Heyden a week ago Saturday put on the market its new Benson addition of 50 lots. On the following Sunday afternoon every one of these lots had been purchased. The Benson addition is on North Sixtieth street, extending east about three blocks. It is north of Main street.

Private Life of Pius XI Marked by Simplicity

Introduction of a Woman Housekeeper Into Vatican Arouses No Little Criticism.

Rome, Sept. 23.—Some interesting particulars have now come to light of the private life of Pope Pius XI in the Vatican. Whenever a new pope is made, there is always a curiosity to know how he is adapting himself to his voluntary seclusion, and what habits he preserves of his previous life. Of the present pope one can say that he confirms the opinion held by all those who knew him well and used to admire his austerity and simplicity.

His holiness has chosen for his private apartments seven rooms on the third floor, overlooking the Piazza San Pietro. These are furnished with the greatest simplicity, there being no carpets, no curtains, and no signs of luxury. In the bedroom there is a brass bedstead, above which hangs a picture of The Madonna of the Good Counsel, to whom Pope Pius XI is particularly devoted; a mahogany chest of drawers, a small writing desk, and a simple wooden chair.

In his study there is a large writing table, with a crucifix standing upon it. No books or reviews are to be seen. Generally, his holiness does his writing in the great library or in the second apartment, where he takes reviews or books from his readers into the private apartment, after he has finished with them he brings them back himself to their places with the methodical care of the old librarian. He does not like to see anything on his writing table and on every hand there is evidence of his love for tidiness and order.

The pope lives entirely isolated in his private apartments, where no guard is on duty either during the day or at night. Nobody sleeps near him. He has three servants, who take care of his daily waiting upon him. But he is particularly looked after by an old woman, whose introduction into the Vatican broke a long tradition, and aroused no little criticism among the pope's entourage. This woman, commonly called La Signora Linda, who is now over 60, has been for 40 years the faithful maid and companion of the mother of the pope. She was an orphan, and Signora Ratti took her out of a convent when still a girl.

When Signora Ratti died, Linda, being alone, re-entered a convent; but when Cardinal Ratti came to Milan as archbishop of the diocese he recalled her and made her his housekeeper. A few months later the archbishop was elected pope, and Linda was on the point of returning to the convent when a telegram arrived from Rome ordering her to go and live at the Vatican.

The decision of Pius XI met with respectful resistance of the cardinals, and it is rumored, even of the secretary of state. "A woman in the Vatican," says "holiness" was remarked to him. "None of your predecessors has ever done such a thing." "Well," was the reply, "we will set a precedent for our successors!" Those who know the affectionate attachment of Pius XI to his family, and particularly the great devotion he always showed to his mother, were not surprised to hear that, in spite of tradition and opposition, he made good his will.

The result is that Signora Linda lives now in the Vatican on the third floor of the wing looking towards Montemario. Her official title is mistress of the wardrobe, and every day she orders the pope's extremely frugal meals.

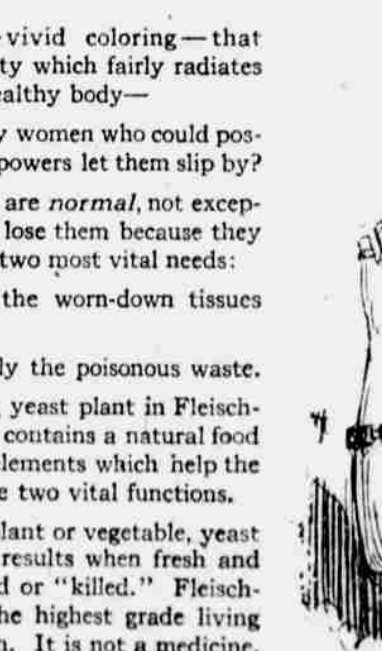
