

### Record of G. O. P. Has Won Voters, Iowa Solon Says

#### Judge Green Cites Reduction in Federal Expenses as One of Big Achievements.

"The republican party will win this election on its record," declared Judge William H. Green, congressman from the Ninth district of Iowa, in Omaha last evening.

Judge Green is up for reelection this November and is slated to become the chairman of the ways and means committee, the most important committee in the house of representatives at Washington.

"A reduction of expenses of nearly \$1,400,000,000 for the fiscal year ending June 30, 1922, from those of the preceding fiscal year, of which all but three months was under the democratic administration," continued the congressman, "is a reduction of \$118,699,000 in the amount of taxes for the calendar year, and a reduction of the public debt of about \$1,000,000,000 in the last 12 months, are achievements of which the present administration has a right to be proud."

The new tariff is the lowest protective measure ever passed, and the best. Its average rate of duty based upon the imports for the last fiscal year is 16 per cent; that of the Payne bill while it was in force was 20.5 per cent; the Dingley bill, 25 per cent. It is estimated to bring in about \$50,000,000 more than the present law which is partly the emergency tariff and partly the Underwood law.

"Like all other republican tariff bills, it will stimulate business and add to our revenues without materially increasing the cost of living.

"Its rates and provisions are being continually misrepresented, but the people will learn the truth before the campaign is over."

#### Bulldog to Testify.

York, S. C., Oct. 12.—A bulldog will be a witness in a murder case to come up in the York circuit court in November, according to attorneys defending Alma Williams, a woman, charged with killing her husband, Harper Williams.

The woman claimed she killed her husband because he often came home drunk and abused the dog so much. On the night of the killing, the dog bit her several times and in order to stop it, she shot Williams, she claims.

The dog will be brought into court and his disposition tested for the jury.

#### Can't Be Done.

Hamburg, Oct. 12.—(By A. P.)—One brown bear cannot whip two polar bears. This was proved in an impromptu battle staged in the Hamburg Zoological gardens yesterday when Brownie slipped unnoticed into an adjoining cage during cleaning operations.

The visiting bruin stood amazed when he found himself confronted by two snarling antagonists who had always appeared as friendly neighbors. Enraged at his reception, he courted fight—and got it. His cries of distress were taken up by the other inmates of the zoo and the air was soon filled with the clamor of hundreds of beasts.

A pugilist who had been visiting a pet cub went to the rescue of the brown bear and succeeded in driving one of his enemies into the next cage. Then he won the bout with the other with the aid of a club.

Brownie limped back to his own cage, but died in a few minutes from his wounds.

But Still Red, White and Blue.

Chicago, Ill., Oct. 12.—In a few years the time honored and traditional red, white and blue barber pole may be obsolete, according to members of the National Barber Supply association now in convention here. In place of the well known barber pole, they said, customers will see a red, white and blue clock. The change was ascribed to an effort to "keep abreast of the times."

#### "Somebody Is Always—"

New York, Oct. 12.—Reisenweber's, one of the few remaining landmarks of the old "west" night life of New York, was ordered closed by Federal Judge Mantel.

The famous cabaret, recently operated as the "Paradise" by the Fifty-eighth Street Restaurant company, has run afoul of the prohibition laws several times in the past two years.

### Standard Oil of New Jersey Plans to Increase Stock

#### Meeting Called to Consider Proposal to Raise Capitalization From \$110,000,000 to \$625,000,000.

New York, Oct. 12.—Following the lead of other Standard Oil companies, Chairman A. C. Bedford of the Standard Oil of New Jersey announced that a special stockholders' meeting has been called for November 8 to act upon a proposal of the directors to increase the authorized capital stock of the company from \$110,000,000 to \$625,000,000, and declare a stock dividend for each share of common stock or a 400 per cent stock dividend for each share of common stock now outstanding. The par value of the new shares will be 125, the same as at present.

The directors also explained that they felt the shareholders should be advised that in view of the requirements of the company for capital investment, they have no purpose to increase the aggregate amount of dividend disbursements at the present time. The present dividend is on the basis of 20 per cent annually.

When this new financing has been completed there will be \$500,000,000 par value common stock outstanding. The balance of the proposed increase, about \$125,000,000, will be held in the treasury to meet such needs of the company as may arise in the future, it was stated.

Mr. Bedford declared that since 1899 it has been the policy of the company to reinvest in its business all earnings

remaining after the disbursement of dividends, and since 1891 there has been no change in the regular rate of dividend. During this period the substantial growth of the company's business, in line with the growth of the petroleum industry generally, has resulted, he declared, in a very considerable augmentation of its assets, largely by reason of profitable employment
