

Huskies Rolling Toward Scene of Syracuse Tilt

Coach Dawson Visits Creighton Wednesday and Joins Team at Station.

"Sure, we'll defeat Syracuse." With these words on his lips, Coach Dawson of the University of Nebraska football team, left the "Wonder team of the west" today for Burlington, N. Y., where, on Saturday afternoon, Nebraska and Syracuse clash in their annual game.

Coach Dawson breezed into Omaha yesterday morning and in the afternoon visited Coach "Mac" Baldridge at Creighton university. The Husker head coach also spent part of the afternoon with members of the Nebraska alumni of Omaha talking over the new stadium which will be constructed on Nebraska field before the 1923 football season opens.

During his visit at Creighton, Coach Dawson inspected the large Creighton gymnasium and commented favorably on the large basketball floor on which the Nebraska hoopers and Creighton tilters play either March 3 or 27.

Headed by Assistant Coach Frank, the 22 Huskers left Lincoln at 4:30 p.m. Wednesday afternoon, arriving at the Burlington station in Omaha at 6:10 p.m., where Coach Dawson joined the team.

Only One Team Not Scored on

New York, Nov. 1.—Michigan, headed toward a Western conference championship, with one of the greatest gridiron machines "Hurricane" Voss has drilled in several years, is the only major college in the country whose eleven has not been scored on this season, according to a recapitulation of records to date.

The Wolverines were held to a scoreless tie by the southern team, Vanderbilt, but have won decisively from other opponents. Eleven with but one touchdown registered against them include Harvard, by Centre Notre Dame, by DePaul, Minnesota, by Northwestern, and Iowa, by Illinois.

Twenty-two teams show undefeated streaks. Listed sectionally, they include:

West—Wisconsin, Notre Dame, Michigan, Iowa, Nebraska and Minnesota.

Far West—California, Washington and Oregon.

Stanley Davis, the husky Field club pro, and Jack Hughes, will furnish the opposition for the invaders in a morning 18-hole match, and Sam Reynolds and Blaine Young will act as pace-makers—or maybe pace setters—in the afternoon.

Good for Irons.

Following 36 holes of exhibition play, the Australian chatup will make trick shots for the edification of experts and duffers.

Kirkwood is without a peer when it comes to making the Gutta Percha do stunts.

Regardless of inclement weather, the matches will be played, it is announced.

As a result of rain for the last few days, the Field course will be in great shape and furnish Hagen an opportunity to show some of the wonderful iron shots for which he is noted.

Crawford High Team Undeclared

Crawford, Neb., Nov. 1.—(Special.)—Coach Smith's gridiron warriors of Crawford High, although from one of the smaller cities of the state, are attracting a great deal of attention in northwestern Nebraska. The Crawford team has won four consecutive games this season and are still in the running for the state championship of Nebraska. They have scored a total of 159 points while their goal line has been crossed but once. Wright Lathrop, one of their backfield men, is no doubt one of the fastest, shiftest and hardest-hitting halfbacks in the state, while Captain Carl Anderson is a fullback of exceptional line-plugging ability. Chadrin High school, Newcastle (Wyo.) High school and Gordon High school have already fallen before the onslaughting attack of this backfield.

Next Friday afternoon the Crawford team meets Alliance High school of the latter's Alliance. Alliance has already established a reputation in state football circles by defeating Sidney, Scottsbluff, Grand Island and scoring two touchdowns on Beatrice before Coach Hughes' boys were able to get started. Arrangements are now being made for a special train to accommodate the enthusiastic rooters of Crawford who expect to accompany their team to Alliance. This will be one of the most important games during this weekend for western Nebraska, as it will determine whether Crawford High school will be eliminated from the state championship race or whether they will pass to the next round in the championship ladder.

Says McGraw Not in Favor of Union

Omaha Bee Leased Wire. New York, Nov. 1.—Charles Stoneham, part owner of the New York Giants, and Secretary James T. Tierney, denied emphatically today that Manager McGraw had permitted any of his players to join the new baseball union.

Raymond J. Cannon, Milwaukee attorney, who has been retained by the union as counsel, earlier in the day, is said to have declared that:

"One hundred and thirty-six of the 175 players in the National league have joined the new baseball players' organization."

"Six of the eight clubs in the league—New York, Cincinnati, Boston, Brooklyn, Philadelphia and St. Louis—have joined almost to a man."

"Twenty-one members of the championship Giants have enrolled with the consent and approval of Manager John McGraw."

Detroit, Mich., Nov. 1.—Bob Cannefax of New York won both 30-point blocks in an elimination match here yesterday in the national three-cushion billiard championship. Cannefax defeated Charles Jackson of Detroit, 10 points to 28 in 27 minutes in the first block and 50 to 45 in the second game, which went 41 innings.

The easterner's high run was six and Jackson's four. The games left Cannefax undefeated after six matches.

Central's Hopes for Victory Slide Backward When Star Players Answer Sick Call

Weather conditions are not hindering the Central high gridsters in their preparation for the annual clash with Lincoln high, Saturday.

Coach Schmidt held indoor practice in the school gym yesterday and sent his squad of followers through a light signal practice. The Purple mentor has been taking advantage of the rainy weather and has been conducting a football class in order to diagram every play and formation.

Several of the Hilltop regulars failed to report for practice yesterday because of injuries and illness. Galloway, Central's all state fullback, appears at the head of the sick list and Lawson, who has been playing half position, comes next. McDermott and Percival were also out of the gymnasium drill last night.

The hopes of turning back the Red and Black eleven took a decided fall as the result of the absence of these regulars and Hilltop followers again received

a hard knock in their championship expectations.

With only two more days of practice to put on the final touches, Coach Schmidt will have to do some fast work to find a good combination to fill the vacancies left open by old man Jim.

Coach "Zip" Hill made an announcement last night that his gold jerseyed reserves will look horns with the Capital City second squad in a curtain raiser to the main event Saturday.

Much athletic activity in the Mid-Western association of the Amateur Athletic union is promised in the 1923 schedule adopted by the association. With the exception of handball, basketball and indoor track, awards of which will be made at a later date, the schedule for 1923 is complete. The championship competitions for the coming year include boxing, wrestling, track and field, gymnastics and volleyball.

A committee has been appointed by the directors of the association to prevail upon the Nebraska legislature to amend the state boxing laws so as to permit amateur boxing and wrestling. Under the present boxing and wrestling laws of the state, all persons, whether amateur or professional, must be registered and licensed by the state boxing commission to participate in boxing or wrestling exhibitions. This, according to officials of the A. A. U., is a decided disadvantage to the amateur.

With the exception of the junior track and field championships and one of the swimming programs, all of the Mid-Western A. A. U. competitions will be held in Omaha in the coming year. The awards of the competitions by the championship committee of the association are:

A. Rule 6, section 15, paragraph 6, states: "If a player commits a foul behind his opponent's goal line which would give the side defending the goal possession of the ball on the field of play, a touchback shall be declared." Holding on a kick gives the ball to the offending side at the spot where foul occurs. Therefore, the play should be ruled a touchback and not a touchdown.

Q. Player fumbled ball and is on ground. As an opponent drives for it he knocks it out of bounds and toward his own goal. One of his teammates recovers ball. What decision should be given on this play?

A. If the man on ground battered ball towards his own goal, the ball should be awarded to opponent at the spot where the foul occurred. Rule 13, section 7.

Q. Onside player on punt from scrimmage touches ball in field of play and it then rolls out of bounds. He falls on it there. Is he given ball as first down at point it left field of play?

A. Yes. The ball goes to his team where it crosses the sidelines. Rule 6, section 13.

Freshies Beat Purple.

Chicago, Nov. 1.—The freshman football squad at Northwestern university went on a campaign yesterday in practice sessions against the first and second varsity teams, scoring 13 touchdowns. The yearling's attack was featured by use of the forward pass which the varsity teams could not stop.

Pilot Question Worrying Coach of Syracuse Team

"Chick" Meehan Undecided Whether to Start Simmons or Frugonne Against Huskers Saturday.

Syracuse, N. Y., Nov. 1.—Coach John E. (Chick) Meehan of the Syracuse university football team is undecided today whether to start his Simmons, the Chicago flash, or Jimmy Frugonne, the Brooklyn star, at quarterback in Saturday's clash with the Nebraska Cornhuskers.

Simmons has been suffering from an attack of pleurisy which laid him low last August at the start of the football season and has not been in form all season. Last year he played a whirlwind game at quarterback for the "flash" and was looked upon as certainly varsity material this season. His illness, however, has hampered his work, and although he has started several games, his work has not been up to that of last year. Frugonne, called signals in the scoreless tie against Penn State Saturday, and his work was of the highest class. Unless Simmons displays a sudden recovery of form it is almost certain Frugonne will start the fray against the Cornhuskers.

Drilled in Husker Plays.

During the first part of the week the freshman and second varsity teams were given long, detailed instruction in Nebraska plays which "Heavy" Van Arman picked out in the battle with Oklahoma last week. While the second string men were getting these instructions the varsity was given only light signal drills, but as soon as they had been perfected the heavy scrimmage work started. The westerners' play puzzled the varsity at first but after a few hours they acquired them all over the place.

The Cornhuskers, regarded as one of the greatest gridiron machines in the country today, will arrive here Friday. Deaf Smith, according to Chicago and Niagara Falls for short practices. They will enter the game a slight favorite over Syracuse.

Believes He Has Best Team.

Meehan believes that he has the best aggregation of football men in the east, but says the detailed instruction in Nebraska plays which they did against Pittsburgh.

"From a football standpoint Syracuse won the Pittsburgh game despite the fact that figures indicate otherwise," he said. "They were on even terms with Penn State, and they should have beaten Penn State. They played the greatest game of their lives against Pittsburgh and they were beaten. They can improve on their showing against Penn State."

Floyd Johnson Knocks Out Vidas

New York, Nov. 1.—Floyd Johnson, San Francisco heavyweight, last night knocked out Joe Vidas of Philadelphia in the second round of a 10-round match. Johnson outclassed his opponent from the start and landed the finishing blow after a minute and 30 seconds of the second round had elapsed.

Both men entered the ring weighing 185 pounds.

Iowa's Acceptance of Yale Game Deferred Until Next Month

Iowa City, Nov. 1.—Iowa's acceptance of the invitation to meet Yale in another international football game in the Yale bowl in 1923 probably will be deferred until after the meeting of the western conference faculty committee scheduled to be held here early in December, it was said in athletic circles today.

The western conference rule in regard to international games is not ironclad, it was pointed out, and does not absolutely prohibit games with members of the "big three" or other eastern eleven, but was designed primarily, according to football observers, to prohibit games such as Ohio State university undertook when the Buckeyes played California in the annual New Year's day game at Pasadena two years ago. The faculty
