Elks Receive Bids for Construction of **New Club House** 

#### Vaughn Construction Company Makes Lowest Bid-Total Cost to Be Near \$800.000. Says Sears.

Bids from contractors were received and opened Thursday night in the club rooms in the presence of all bidders and a large number of club members Estimates average around \$600,000 for general construction and an additional \$200,000 for heating, ventilat ing and lighting, according to Judge Serrs. Time of from a year to a year and a half was asked for construct

The Vaughn Construction company made the lowest bid among the general contractors. Its estimate was 509.462, with an alternate bid of \$730,000. The time for construction was put by the company at 365 days. Other contractors making general bids were Selden-Breck Construction company, Home Builders, Inc.; John ompany, Thomas Herd and S. 
