Lincoln, March 2 .- The following statement has just been made public by C. H. Gustafson, candidate for renomination for governor:

"I want to frankly say that if the people of Nebraska sincerely feel that can effectively administer the affairs of the state, I shall do all in my power to prove worthy of that confidence.




