

### Butler Will Run as Progressive

#### Secretary of State Told to "Do What He Likes" With Petition.

Secretary of State Charles W. Pool has announced that Dan B. Butler must indicate whether he wishes to make his gubernatorial campaign as progressive candidate or candidate by petition, indicating that the Omaha commissioner cannot do both.

John F. Moriarty, attorney for Butler, advised the secretary of state that Butler will not abandon his nomination for governor on the progressive ticket.

"Moriarty told Pool that he can do what he wishes with the petition filed for me, and that I stand first for progressive nomination," Butler said.

"As a matter of fact, I contend that I am entitled to go on the ballot as progressive candidate and also as candidate by petition, but if the secretary of state wishes to take the arbitrary position that I cannot do both, he will have to abide by the consequences."

"Pool has attempted to block me all around my petition from Moriarty, and the law is plain as to what he shall do when a sufficient petition is filed with him. If he would go to the attorney general's office in Lincoln he would be advised as to the law in a case of this kind."

Butler's campaign cards being distributed refer to him as "progressive candidate."

The secretary of state will certify names of candidates that are to go on the ballot to county clerks October 14.

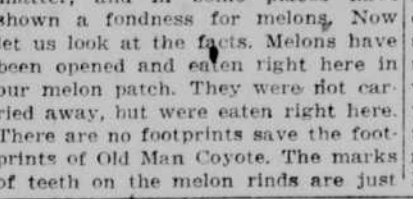
