Urges Esch-Cummins Law Repeal.


"As we say in our platform, the immediate issue is the repeal of the Esch-Cummins railroad law and the substitution of a scientific method for the adjustment of freight and passenger rates and a proper method for peaceable adjustment of indus trial disputes on the railroads. La Follette attacked the Esch-Cum

mins low for "practically destroying the state railroad commissions, which had been built up to protect the peo ple from the grip of the railroads." He said the Interstate Commerce com mission had accepted substantially the claims of the carriers regardin the value of their properties and had fixed the aggregate value for ratemaking purposes at \$18,900,000.
