

REVISED PARKING PLAN SUBMITTED

Committee Urges Abolishing Auto Impounding; Police Officer to Collect Fines

City Commissioners Joseph Koutsky, J. B. Hummel and Dean Noyes Tuesday morning submitted to the city council proposed revisions of the downtown automobile parking regulations. They were recently named as a special committee to investigate and report. Their report, which follows, was referred to the city council committee of the whole next Monday morning for consideration:

1. That the 10-minute downtown parking limit be eliminated. 2. That the present "no parking" spaces be eliminated. 3. That the superintendent of the police department be authorized to issue parking permits for a foot width in any one block along any one street.

4. That the merchants occupying the downtown store building be permitted to park their cars and trucks on the sidewalk in front of their stores, subject to the permission and authority of the chief of the fire department.

5. That cars be permitted to be parked along the curb on more than two feet back from the property line of cross-street, where street cars are not permitted to pass.

6. That the parking spaces and safety cones be designated by plain marking on curb, pavement or on some other surface in the street which would be most suitable for such purpose.

7. That the parking of cars be done away with, as this seems to be the most unpropitious procedure.

8. In order to speed up the enforcing of the rules herein made, it is suggested that the superintendent of police, or some responsible officer or officers, one to be duty at the police station during all hours.

9. That the driver being tagged be directed to appear before that officer, who shall have the power and right to collect penalties as follows:

Two dollars for parking over the time limit and parking in no parking spaces. This penalty on week days, Sundays are excepted.

Three dollars for parking in restricted water plaza.

Five dollars for parking in front of water plaza.

That any money thus collected shall revert to a special fund for use in marking safety cones, providing the sign and for paying the expense of material, labor and the salaries of said officers charged with enforcing the above prescribed rules.

The driver who pleads guilty before the officer may be allowed a 10-minute grace period to appear in police court, where he would be tried in the usual manner.

Failure to appear before the officer would be prima facie evidence of guilt, and warrant should be issued at once.

After the second offense against the above rules by any one driver, or after any driver has been tagged for parking in no parking spaces, or for parking in restricted water plaza, the driver to appear before the proper court.

That the rule allowing two taxicabs in any one block on either side of the street be enforced.

That the taxicab companies be instructed either to remove their call boxes in the outlying districts of the city further away from the street intersections, or to remove their drivers and obstruct sidewalk lines of the streets.

Some of the members of this committee have seen these conditions exist and give locations if the taxicab companies are not removed.

That all cars bearing "official car plates" shall be excluded from the above rules.

In conclusion, most earnestly and emphatically recommend that the above rules be enforced as written, and that the city council see fit to approve this report.

Lieut. Erik Nelson, pilot of the third plane among the United States army globe fliers and engineering officer of the world flight, has been invited to come to Omaha in April as guest of honor at the annual banquet of the Noonday club.

This banquet will be held between April 12 and 29.

Prof. A. A. Stomberg of the University of Minnesota, who was knighted with the Order of the North Star by the king of Sweden for scientific research work, will be the speaker of the evening.

Lieutenant Nelson's leave will expire March 15, but officers of the Noonday club are in communication with General Patrick of the air service and Secretary of War Weeks in an effort to get him special leave to come to Omaha for the occasion. Secretary Weeks has indicated he will act favorably on the request.
