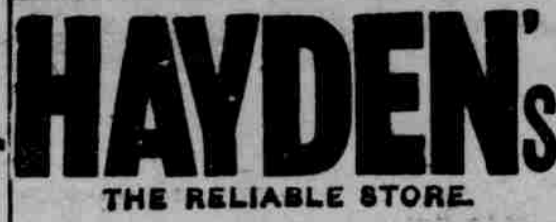
Miscellaneous

Ex-President Cleveland paid the following very eloquent tribute to his friend, the great actor, Joseph Jefferson, who died last Monday: "It is difficult for me to speak of Mr. Jefferson. He was closely my friend, his delightful traits were made so manifest to me in a confidential intimacy, and my love for him was so great that his death caused me to feel like a mourner whose sorrow should be silent. All knew my friend's professional supremacy and his conscientious service in professional work; many knew how zealously he defended dramatic art and how completely he illustrated the importance of its cleanliness, many knew how free he was from hatred, malice and all uncharitableness, but fewer knew how harmoniously his qualities of heart and mind and conscience blended in the creation of an honest, upright, sincere, and God fearing man. I believe that in death he has reached a world where the mercy of God abounds; and I know that in the world of men the sadness of his loss will be felt the most by those who knew him best."

The appropriation by congress for the improvement of the Missouri river this season will be expended as follows: Ninety thousand dollars will be expended below and \$88,000 at and above Sioux City. The amounts below Sioux City are: Omaha, repairs to retentment on Iowa side and below terminal bridge, \$5,000; Nebraska City, rescreening of dikes, \$500; St. Joseph, general repairs to works in Bonton bend, Elwood and Belmont bends, \$15,000; Little Blue beach, repairs to dikes and constructing three short dikes, \$4,000; Lexington, Mo., for repairs to dikes opposite town and building two new dikes, \$2,500; Miami, Mo., for repairing dike opposite town, \$300; Wilhoit bend, for building three new short dikes and making general repairs, \$5,000; First beach, for making repairs to Murray bend and for general repairs to old work, \$25,000; for snagging, two seasons, \$20,000; for contingencies, \$12,700. Total, \$90,000.

There is a panic in the executive departments over the possibility of wholesale dismissals, and punishment of prominent officials may occur through a little provision put into the last law making appropriations for deficiencies in the government's expenditures. Practically every department has spent or incurred obligations which will necessitate the disbursement of every penny appropriated for the present fiscal year; and there remain two months of the fiscal year yet to run. As has been the custom in the past it was intended in order to continue government work to authorize contractors and employes to go ahead with their jobs and ask congress to make deficiency appropriations.

# A New Book

By William J. Bryan, Entitled

## Under Other Flags

Travels, Speeches, Lectures.

SINCE Mr. Bryan's European tour a year ago he has been besieged by requests for copies of letters describing his travels abroad. These letters together with a number of his lectures and other public addresses, have been gathered together and published in book form. The European letters contain Mr. Bryan's account of what he saw and learned while in Europe, and present interesting views of Ireland, England, Scotland, France, Switzerland, Germany, Russia, Holland, Belgium, and the Netherlands, together with a description of his visits with Count Tolstoy and Pope Leo. In this volume Mr. Bryan writes entertainingly of the "Birth of the Cuban Republic." He also included his lectures on "A Conquering Nation," and "The Value of an Ideal."

Other articles in the volume are "The attraction of Farming," written for the Saturday Evening Post; "Peace," the address delivered at the Holland Society dinner in 1904; "Naboth's Vineyard," the address at the grave of Philo Sheridan Bennett; Democracy's Appeal to Culture, address before the Alumni Association of Syracuse University; and an account of his recent trip to the Grand Canyon entitled "Wonders of the West." The book is illustrated, well printed on good paper and substantially bound.

One of the features of "Under Other Flags" is the "Notes on Europe," written after his return from abroad, and giving in brief form a resume of the many interesting things he saw.
