NATIONAL CONTROL

SENATOR DRYDEN SOUNDING PUBLIC ON THE QUESTION

Intends to Introduce a Bill and is Anxious to Secure Favorable Answers to His Circular Letter Containing List of Questions

New York, Oct. 15 .- For the purpose of securing a comprehensive expression of public opinion on the question of national control of life insurance companies, United States Senator John F. Dryden of New Jersey has sent out many copies of the following circular letter, with the appended list of questions to be answered:

President Wants It

In his last annual message, President Roosevelt called the attention of congress to the necessity for federal legislation providing for the regulation and control of insurance companies transacting interstate and innational business. In compliance with an increasing demand from insurance policyholders and others interested in the public welfare I introduced into the last congress a bill to this, effect, providing that there should be established within the bureau of corporations a division of insurance, and that policies of insurance were deemed to be articles of and instrumentalities thereof. This was introduced too late to secure final consideration, but the demand for such a measure has become even more apparent in the meantime and I expect to reintroduce the same, possibly with slight modifications, into the congress which is to meet in December.

The bill will be introduced on behalf of the policyholders of all American insurance companies in the firm belief that their present and future interests demand the additional protection of a federal statute regulating insurance transactions between the states, in addition, of course, to such supervision and regulation as constitutionally belongs to the states of which the companies derive their charters. Furthermore, that by elimnating a considerable amount of need less state supervision, the following important benefits are expected to re-

First-An increase in the security of the policyholders. Second-A decrease in the expense

rate and the cost of insurance. Third—A decrease in the burden of

Fourth-A decrease in the amount of clerical labor now indispensable to meet the requirements of some fifty states and territories.
