The complete list follows: butter. raisins, rice, pork lard, pork corn meal, shell eggs, dried prunes, hominy grits, dry edible beans, wheat flour, white wheat (Graham) flour, fresh oranges, fresh apples, fresh pears, fresh peaches, fresh carrots fresh beets, fresh cabbage, fresh celery, fresh corn and fresh tomatoes.

The new item on the list for this area is fresh carrots. Fresh snap beans have been deleted from the list.
