The crowd was mostly from around Broken Bow and the general absence of people from a distance was noticeable. There was a great contrast between the 1,500 people at the circus and the 7,000 people who went through the gates on the big day of the fair last year. An unusual effort is being made for a grand time at the county fair in September and it is practically assured that an attendance of 10,000 people will be here on the best day. PROPOSED CONSTITUTIONAL AMENDMENT.

The following proposed amendment to, and correction of, the Constitution of the State of Nebraska, as hereinafter set forth in full, is submitted to the electors of the State of Nebraska, to be voted upon at the general election to be held Tuesday, November 8, A. D. 1904.

(SENATE FILE NO. 114.) A Bill for a Joint Resolution recommending to the electors of the state to vote at the next election of members of the Legislature for or against a convention to revise, amend and change the Constitution of the State of Nebraska in accordance with Section 2, Article 15, of the Constitution of the State of Nebraska.

1. That it is deemed necessary to call a convention to revise, amend and change the Constitution of the State of Nebraska.

2. That the electors are recommended to vote at the next election of members of the Legislature for or against a convention to revise, amend and change the Constitution of the State of Nebraska.

3. That such next election of members of the Legislature on the ballot of each elector voting in such a manner that the elector can indicate his preference under the law the words: "FOR calling a convention to revise, amend and change the Constitution of the State of Nebraska," and "AGAINST calling a convention to revise, amend and change the Constitution of the State of Nebraska;" and if a majority voting, at said election shall vote for a convention, the Legislature shall, at its next session, provide by law for calling the same.

4. That the Governor of the State of Nebraska, do hereby certify that the foregoing proposed amendment to the Constitution of the State of Nebraska, and providing for a Convention for the revision of said Constitution of the State of Nebraska, is a true and correct copy of the original enrolled bill passed by the Twenty-eighth session of the Legislature of the State of Nebraska, as it appears from said original bill, on file in my office, and that said proposed amendment and revision of the Constitution of the State of Nebraska, is submitted to the qualified voters of the State of Nebraska, for their adoption or rejection, at the general election to be held on Tuesday, the 8th day of November, A. D. 1904.

In testimony whereof, I have hereunto set my hand and affixed the Great Seal of the State of Nebraska.

Done at Lincoln this 5th day of July in the year of our Lord One Thousand Nine Hundred and Four, of the Independence of the United States the One Hundred and Twenty-Ninth and of this State the Thirty-Eighth.

ORDINANCE NO. 44.

An ordinance appointing a water commissioner and fixing his term of office and fixing his duties and salary and requiring him to execute bonds and fixing rates for the government of Broken Bow and water users generally for the use of water, water meters and hydrants, apparatus and appliances, and to provide a fine or imprisonment of any person or persons who shall unlawfully, willfully or maliciously violate the terms of this ordinance, and to provide a fine or imprisonment for any person or persons who shall unlawfully, willfully or maliciously meddle with, tamper with or damage or destroy any machinery, fixtures or apparatus or property of any sort pertaining to the said water works system or that may be used in connection therewith, whether the property of the said city or otherwise, or who shall pollute the water furnished by or pertaining to the water works system of Broken Bow in any manner whatever, and to provide a fine or imprisonment for any person or persons who shall unlawfully, willfully or maliciously meddle or tamper with or damage or destroy or attempt to damage or destroy or attempt to damage or destroy any property or structure or erection of any sort or description belonging to the said city, and to provide a fine or imprisonment for any person or persons who shall unlawfully, willfully or maliciously meddle or tamper with or pollute the water
