Eclipse of Moon To Night.

The almanac manufacturers say there will be a total eclipse of the moon tonight. The moon will enter the dark shadow at 11:57 and the total eclipse will begin at 12:58. At 1:47 it will reach the middle stage. At 2:36 the total eclipse will end and at 3:37 the face of the moon will be fully visible except for clouds. Homeseekers Information Bureau.

The Chicago, Burlington & Quincy Railway Co., has established a Home Seekers Information Bureau department to their line of business.

Mr. D. Clem Deaver is their agent. The plan of the company is to give excursion rates on certain dates to home seekers and provide them with all possible information, free of cost and assist them in locating on government land in this and other land districts of the state, where government land can be had. Mr. Deaver informs us that his Bureau already has received six hundred inquiries and that 100 of them did not know they could file on a section homestead.

The first excursion will be run to this place about the first of April. The company will provide itself with duplicate plats of all land subject to homestead entry so the homeseekers will be able to know just where land can be had.

This certainly is a laudable enterprise and will not only result in settling the vacant land, but better still it will help many to secure homes for themselves that otherwise would never be able to possess one.

Several corn wagons still ornament the landscape.

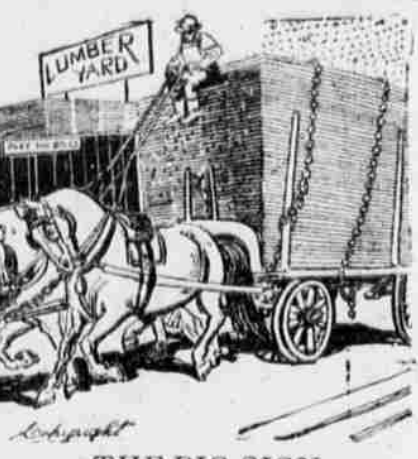
