Political Conventions,

A law passed by the last Legislature provides that a state convention shall be held by the various parties on the last Tuesday in July. This will make the convention this year come on July 27th, or a week from next Tuesday. The law also provides that a delegate county convention shall be held at a date prior to the time of the state convention. The law does not say how these delegates to the county convention shall be chosen. If conventions are to be held according to this law before July 27th to elect a county committee and delegates to the state convention it is high time that the chairman of the party committees in this county get busy. The law governing the new political convention is as follows:

Sec. 1. Party Committees .-The state, congressional, judicial and legislative committees of the various political parties shall be chosen in such manner as may be determined by the state central committee of each respective party. County committees shall be selected by the delegate convention. various officers and committees now in existence shall exercise the power and perform the duties herein prescribed until their successors are chosen in accordance with this act.

There shall be held a delegate county convention in each county prior to the time of holding the state convention is provided for in this section, at which convention the delegates to the state convention and the members of the county central committee shall be selected; said convention shall transact such other business as shall properly come before it. Delegates to national conventions of the various political parties shall be selected at a state or state and congressional conventions composed of delegates chosen in such manner as may be determined by the state committees of each respective party. Provided that the delegates to such state or state and congressional convention shall shall be appointed by such committes to the several counties upon the vote cast at the last election for electors for president and vice president in the respective counties; and, provided further, that each county shall be entitled to at least one delegate in such convention or conventions.


