WOMAN UPSETS TEXAS VOTE Succeeds Late Husband in Campaign Against Democrats.

LUFKIN, TEX., Nov. 11.—Full returns from the election of Tuesday, just received, show that Mrs. Brit Trevathan has defeated W. J. Ivy, the democratic nominee for county clerk of Angeline county. Her majority is about 200. Mrs. Trevathan's husband held the place and was the party nominee for re-election, but died. His widow was appointed to the position but the county committee declined to nominate her for the vacancy, naming W. J. Ivy. Mrs. Trevathan then waged a vigorous fight as an independent. This is the first time a democratic nominee was ever defeated in this section, and it took a woman to do it.—Kansas City Journal, Nov. 12.
