Section 2: At such election, on the ballot of each elector voting for the proposed amendments to the constitution, shall be written or printed the words: "For proposed amendment to the constitution, prohibiting the manufacture, sale and keeping for sale of intoxicating liquors as a beverage." or "Against the proposed amendment to the constitution prohibiting the manufacture, sale and keeping prohibiting the manufacture, sale and keeping for sale of intoxicating liquors as a beverage."

There shall also be written or printed on the ballot of each elector voting for the proposed amendment to the constitution, the words: "For proposed amendment to the constitution that the manufacture, sale and keeping for sale of intoxicating liquors as a beverage in this state shall be licensed and regulated by law," or "Against said proposed amendment to the constitution that the manufacture, sale and keeping for sale of intoxicating liquors as a beverage shall be licensed and regulated by

Section 3: If either of the said proposed amendments shall be approved by a majority of the electors voting at the said election, then it shall constitute section twenty-seven [27] of article III of the constitution of this state.

Provided, that the judges of the supreme court whose terms have not expired at the time of holding the general election of 1891, shall continue to hold their office for the remainder of the term forwhich they were respectively elected un-der the present constitution."


