Whereas, more than fifty petitioners, each being a resident elector and freeholder within the city of McCook in Red Willow County, Nebraska, have petitioned the Mayor and Council of said City of McCook to call a special election in and for said city for the purpose of submitting to the qualified electors of said city a proposition to issue the bonds of said city in the sum of Ten Thousand Dollars for the purpose of aiding in the erection and construction of a court house within the city of McCook, the county seat of Red Willow County, Nebraska.

Said bonds to be issued in a series of five hundred dollars each, to bear interest at the rate of six per cent, per annum, payable annually on the first day of May in each year after the issuance of said bonds.

Said bonds to mature in twenty years from the date thereof, but all or any of said bonds to be payable at the option of the City of McCook at any time after five years from the date thereof.

Shall the Mayor and Council of the City of McCook borrow money and pledge the property and credit of said city upon its negotiable bonds in the sum of Ten Thousand Dollars, the sum being less than five per centum of the assessed value of the taxable property within the limits of said city, for the purpose of aiding in the erection and construction of a court house within the city of McCook, the county seat of Red Willow County, Nebraska.

Said bonds to be issued in a series of five hundred dollars each, to bear interest at the rate of six per cent, per annum, payable annually on the first day of May in each year after the issuance and date thereof.

Said bonds to be issued and sold at not less than par and mature in twenty years from the date thereof, but all or any of them to be payable at the option of the City of McCook at any time after five years from the date thereof. And shall a tax be levied each year after the date of said bonds upon the taxable property within the limits of said city to pay the interest upon said bonds, and a further tax levied thereon to pay the principal and redeem said bonds when the same become due.
