Recipe for Hog Cholera.

The following recipe for hog cholera has been handed us by W. G. Higby of Valley Grange precinct, who has used the medicine with success in the east and is now using the same here. We submit it for what it is worth:

RECIPE FOR HOG CHOLERA.

- Sulphur.....2 lbs.
- Madder.....2 lbs.
- Saltpetre.....2 lbs.
- Spanish Brown.....2 lbs.
- Black Antimony.....1 lb. 8 oz.
- Coppers.....1 lb.
- Fennegreek.....10 oz.
- Resin.....6 oz.

Grind and mix well.

DIRECTIONS.

Put a heaping tablespoon in a common pale and pour in just enough water to mix the medicine; then fill it full of water or swill. Give your hogs all they will drink, mixeb in this proportion, once or twice a week for a preventive; and to remove worms i sick give one teaspoonful in milk to each hog once a day.

This medicine is an excellent condition powder and if fed to hogs twice a week while being fattened will repay its cost many times over in the extra amount they will gain. An ounce of prevention is worth a pound of cure, especially in taking care of hogs. Keep the pens clean, give them a change of feed occasionally, feed salt and ashes often. Sand or sandstone if broken up is eaten greedily by them and is very beneficial.


