From Tuesday's Daily— This morning Judge W. W. Wilson was here to hold a session of the district court and take up the matter of Leona Maupin, et al vs. the City of Plattsmouth, an action in which the plaintiffs, owners of land in the extreme south part of the city, seek to have it set outside the corporate limits of the city.

Among those attending the hearing was Will M. Maupin, state railway commissioner and father-in-law of the plaintiff. While here Mr. Maupin had the opportunity of visiting with a few of the old friends, among these Mr. E. King of the Nebraska Masonic Home, both being old time printers back in the "hand set" days of the craft and had worked together on several of the well known papers in St. Joseph, Omaha and Lincoln.

In conversation with a representative of the Journal, Mr. Maupin states that he is seeking re-election as member of the state railway commission, which post he has very acceptably filled for the past five years.

In the case of Leona Maupin et al vs. the City of Plattsmouth, the evidence was submitted to Judge Wilson in the district court Monday afternoon and the attorneys for the parties will submit briefs to the court covering their arguments in the case.
