



AMERICAN LEGION **COMMUNITY BUILDING CLUB REPORT TO MEMBERS**

Besides paying \$6,150 in salaries to elected presidents who were qualified to serve by having weekly dues paid at the time of their election, the American Legion Community Building Club has invested its entire earnings in worthwhile community enterprises. The major part has gone to reduce indebtedness on the Plattsmouth community building, until now there remains only \$800 more to pay. Nearly \$220 has been expended for shoes for school children, \$165 for Boy Scout work, \$150 on Junior Drum Corps and more than \$40 in support of Recreation work for the youth of our community. Not one cent of the money is spent for Legion social activities, as will be noted from the following detailed report:
