Just Talk . . .

Had it not been for the steady purr of an airplane the other day our attention would not have called to the blue heavens. What looked to be a tiny glider remained in the wake of the swiftly moving plane, and long after the plane had disappeared from sight our neck remained craned back while we observed the floating object which we reasoned could only be a bird. Such observations are contagious, for in the next minute or two others had looked up to see and follow the movements of the winged thing, though movements here meant only the course taken in the sky. Vision was strained for some time before any sort of wing movement could be detected, and then on the slightest flutter. The bird drifted much as a piece of paper on a body of water. Mostly it worked sideways describing huge arcs, and never seeming to lose height. A fellow watcher ventured the guess that perhaps it was an eagle; maybe so, or maybe just an ordinary bird we've never noticed before. Just the same, we'd like to know.

Many, who once obeyed the slogan "Refresh Yourself" and regularly guzzled the sparkling brown liquid from the familiarly shaped bottle, have not yet learned the true facts surrounding the scarcity of America's most popular drink—just in case there might be a misunderstanding we're referring to Coca Cola. A regional distributor told us this morning that contrary to some beliefs, the trouble is not a difficulty in securing the extract from the all important cola bean. Its the sugar story again; essential in sweetening the syrup, the sugar must be the pure cane variety. Use of beet sugar results in the forming of a foam in the neck of the bottle, we are told. About the cut in supply—that's 30 per cent under last year's figure.

Hunters have been forced to give up or curtail their pursuit of game since the war effort got in full swing. This situation recently came before the public when hunters clamored for ammunition for the coming season. As long as the war effort is not impeded, we can't say we blame the hunters. We are rather prone to think that in these days of meat rationing, roast duck or pheasant on the table would go a long way toward bolstering civilian morale. Officers Clear Up Several Burglaries In This Community

Carl Bailey Held at County Jail After Being Caught Selling Stolen Chickens Tuesday

Late Tuesday afternoon Sheriff Joe Mrasek, Deputy Sheriff Emory Doody, and Chief of Police Noah Parker, in quick moves, rounded up Carl Bailey and revealed a cache of stolen goods at the Bailey and Rainey homes on Wintersteen hill where they had been hidden.

The officers received a tip that Bailey was stealing chickens from the George Stones place on Wintersteen hill and the search for the man was taken up by the officers. They drove out to the west part of the city to try and locate the man, and then the car he had been driving, was seen parked near the Plattsmouth Creamery. The officers rushing into the building caught Bailey in the act of taking money in payment for the chickens. He was then taken to the county jail and the officers proceeded to Wintersteen hill to visit the place of residence of Bailey.

One of the first objects revealed was a radio and clock that were identified as having been stolen from the office of the Plattsmouth Creamery last fall. A search uncovered a trap door leading to an attic, where was discovered a large box of dishes that had been taken from the George Hasley residence, the loss being reported to the officers on Sunday. A set of glasses and a tea kettle was also found carefully concealed—these also being from the Hasley home.

The articles had been concealed by Bailey apparently without the knowledge of the owners of the premises where they were found. The fast work of the officers uncovered three separate cases of law violation and they are to be commended for their excellent handling of the case.
