Senator Van Nuys Dies

Washington, Jan. 25. -(UP)-Sen. Frederick Van Nuys, D., Ind. chairman of the important Senate Judiciary committee and a member of the senate since 1932, died suddenly at his country home in Vienna, Virginia early today.

Van Nuys was sixty-nine. His office said he had not been ill and that he had scheduled a hearing today of the judiciary sub-committee investigating the liquor industryan inquiry which he sponsored.

Van Nuys first won a senate seat in 1932 in the Roosevelt landslide. In 1938 he was re-elected after a bitter fight in which he failed at first as a victim of the "purge" aimed at opponents of President Roosevelt's supreme court reform. Van Nuys threatened to run as an indetendent bui finally was
