Release Men to Save Crops

San Francisco, April 15. (UP)—Release of 29,000 men from the Australian army was necessary to save food crops for allied troops, John A. Beasley, Australian minister for supply and shipping, said here yesterday.
Beasley denied recent reports that Australia had planned to withdraw 90,000 men from the armed forces. "The statement simply is not true," he said.
Enroute to the international labor office conference in Philadelphia Beasley told a press conference that when the war started, all able-bodied men in Australia were inducted into the armed forces. Due to the resulting serious impairment of food production, the country was hard pressed to supply its own and American troops in the southwest Pacific, and Great Britain, he said.
His government decided to release 20,000 men over a nine-month period, after consulting with the allied
