

Right Rev. Monsignor George Agius To Celebrate Golden Jubilee Oct. 17

The Rt. Rev. Monsignor George Agius, D. D., J. C. D., V. F., will commemorate fifty years of service in the priesthood on Wednesday, October 17, when he celebrates the golden jubilee of his ordination in St. John's Church.



Monsignor Agius

marked the 40th anniversary of his ordination.

Assistant priest of the Mass will be the Rev. Albin Bauer, C. P. S.; deacon, the Rev. Charles Bauer, C. P. S.; subdeacon, the Rev. E. A. Orzechowski; master of ceremonies, the Rev. Edward C. Tuckey; and chaplains to the Bishop, Fathers A. M. Faessler and E. C. McFadden. The Very Rev. Thomas Bowdren, S. J., will preach. A large number of the priests of the diocese and of the laity are expected for the event.

Following the Mass a dinner will be served in the Eagle's hall by the parish ladies. Mayor R. B. Hayes and Rev. T. Porter Bennett will extend greetings. Walter E. Smith will speak on behalf of the parishioners, and Louis Lorenz will read an original poem. The Rev. James P. Hennessy will speak on behalf of the deacons, and the Rt. Rev. Monsignor Francis A. O'Brien, in behalf of the other deans of the diocese. The program will be concluded with talks by the Bishop and the jubilarian. Father McFadden will be toastmaster.

A committee of St. John's parishioners are accepting contributions to a purse to be given to Monsignor Agius as a gift of appreciation.

Monsignor Agius said Friday that non-Catholics would be welcome to attend the Mass and banquet.

Born Jan. 10, 1872, the prelate was ordained in Malta in 1895. He then was enrolled in the Pontifical seminary in Rome for post-graduate courses in theology and canon law. It was while he was a student in Rome that Monsignor Agius and Eugenio Pacelli, now Pope Pius XII, were classmates.

Monsignor Agius came to the Diocese of Lincoln in 1902, and was immediately appointed Chancellor and secretary to Bishop Thomas Bonaeum. Ten years later he was appointed pastor in Seward, being transferred to Geneva in 1916, where he remained until he was named to St. John's in Plattsmouth in 1927. He was named a Domestic Prelate to the Pope in 1937.

Mayor Proclaims Saturday, Oct. 27 Navy Day Here

Mayor R. B. Hayes signed a special proclamation Tuesday morning proclaiming Saturday, October 27 as Navy Day.

October 27 was chosen because it marks the anniversary of the date in 1775 when the Continental Congress received the bill providing for the creation of an independent fleet. It is also the birthday of Theodore Roosevelt, who recognized the need for a strong navy and is widely credited with being the father of our modern navy, now the most powerful in the world.

The proclamation reads as follows: "Whereas, the United States Navy has fought and won the battle for freedom in the waters of the aggressors, and whereas, the United States Navy, conjoined with its famed coordinated arm, the United States Marine Corps, has enabled our combined forces to plant the Stars and Stripes in every spot once held by the common enemy, and whereas, by national tradition the debt the people of the United States owe their Navy is annually emphasized to the setting aside of one day to acclaim that branch of the armed forces;

Herman Ludwig Gets Silver Star For Gallantry

(Special to The Daily Journal) Mrs. Henry Ludwig of Avoca has received a notice that her son, S. Sgt. Herman H. Ludwig, has been posthumously awarded the silver star, third highest decoration. The message was signed by Brigadier General Robert H. Dunlop, acting adjutant general. He stated that the decoration would be sent to the commanding general of the 7th Service Command in Omaha, who in turn would select an officer to make the presentation.

The citation reads as follows: "For gallantry in action in North France, in the vicinity of Pont L'Abbe, France on June 12, 1944, when his platoon withdrew from untenable position, Sgt. Ludwig as acting squad leader, did, without regard for his personal safety, remain alone in an exposed position to cover its withdrawal by throwing hand grenades. After arrival at the new position, Sgt. Ludwig noticed one of his men missing. He returned in the face of enemy fire to the position just given up to find the man wounded and succeeded in bringing him back to the new position. Sgt. Ludwig's courage and loyalty to his men was in accordance with military tradition and of great inspirational value to his platoon."
